The DSSSB vide its advertisement no. 02/2018 with closing date 13/08/2018 and Addendum dated 26.08.2019 had advertised 1024 vacancies (UR-516, OBC-277, SC-154, ST-77 including EXSM-102 & PH(OH)OI-41) for the Post of Nursing Officer under post code 03/18 in Health & Family Welfare Department. The Board had conducted Tier-I (I) written examination on 27th 28th, 29th 30th August 2019 and 30th September 2019(online).
2. DSSSB vide Result Notice Nos. 996 dated 13.06.2020, 1058 dated 30/09/2020, 1086 dated 11/12/2020, 1123 dated 30/03/2021 and 1131 dated 08/05/2021 has provisionally selected 763 candidates, 147 candidates, 12 candidates, 76 candidates and 58 candidates respectively for the post of Nursing Officer under post code 03/18 in H&FW Department, GNCTD.
3. The user Department i.e. H&FW Department, GNCTD vide letter nos. F.8(257)/Nursing/H&FW/2020/1060-63 dated 08/06/2021, F.8(257)/Nursing/H&FW/2020/1067-70 dated 11/06/2021, F.8(257)/Nursing/H&FW/2020/1075-1078 dated 11/06/2021, F.8(257)/Nursing/H&FW/2020/1079-82 dated 11/06/2021, F.8(257)/Nursing/H&FW/2020/1041-44 dated 03/06/2021, F.8(257)/Nursing/H&FW/2020/1032-35 dated 27/05/2021 and F.8 (257)/ Nursing/H&FW/2020/997-1000 dated 18/05/2021 returned 84 selected candidates (UR-27, OBC-14, SC-17, ST-10, PH(OH)(OL)-14 & EXSM-02) on the ground that selected candidate either did not accept the offer of appointment or did not respond within the specified period. The validity of the waitlist panel for the post code 03/18 is upto 12/06/2021 and the returned dossiers were received prior to expire of waitlist panel, hence, candidates from waitlist panel have been considered for selection against the vacant post created due to returned dossiers.
4. Now, on the basis of written examination Tier I (T) held on 27th 28th, 29th 30th August 2019 and 30th September 2019(online) and as per documents uploaded in support of educational qualifications, age, etc. in accordance with the Advertisement No. 02/2018 and RRs for the post of Nursing Officer under post code 03/18 in H&FW Department, GNCTD, the following candidates are provisionally nominated as per their merit:-

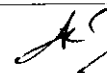

Note:- Some representations have been received where candidates have submitted that registration with Nursing Council has not been mentioned in the Advertisement as well as part of essential qualification in RRs of the said post. Since the essential qualification related for the said post code is technical in nature therefore, at this stage DSSSB has not undertaken the veracity/scrutiny of the essential education qualification furnished by the candidates as such User Department i.e. H&FW Department, GNCTD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate as per nature of job, provisions of RRs of the said post and requirements of the Department. The selection is provisional and subject to satisfaction of User Department regarding essential qualification furnished by above candidates.



Note:- as per RR of the said post code one of the essential qualification is that the candidate should be able to speak Hindustani fluently. Since presently process of interview is dispensed off with the Board therefore Board has not examined this aspect.

5. The candidature of 01 candidate having roll no. 12380902332 earlier selected in OBC category now shifted to the UR category. Further, candidature of 05 candidates having roll nos. 11300900408, 11230901355, 12380901742, 11320900662, 11230901344 earlier selected in SC category now shifted to the UR category. Further, candidature of 01 candidate having roll no. 11320901439 earlier selected in ST category now shifted to the UR category as per their merit in the post code 03/18.
6. The candidature of 05 candidates having roll nos. 11290900427, 11350900627, 12370903756, 11180900782, 12380903801 are hereby not considered in OBC (Delhi) category as the candidates are not eligible to seek the reservation benefits under OBC Category in Delhi being OBC Outsider.
7. 01 post in OBC Category still kept withheld till finalization of representation of the candidate having roll no. 11280901445.
8. The selection of the above 68 candidates (UR-20, OBC-15, SC-22, ST-11) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
9. The Selection of the above 68 candidates (UR-20, OBC-15, SC-22, ST-11) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
10. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Health & Family Welfare Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User



Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

11. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
12. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
13. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
15. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
17. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
