ORDER

Whereas, Mr. Sunil Dangi (DoB : 18.10.1991) s/o Sh. Rohtash Dangi r/o Village Madina (Korsan), Tehsil : Meham, Distt. : Rohtak (Haryana) had applied for the vacancy of Assistant Teacher (Primary), Directorate of Education, Govt. of Delhi under post code 89/17 of advertisement No. 04/2017 dated 20.12.2017 issued by this board and he appeared for computer based test at IoN Digital Zone - 2, IDZ-2, Sec 62, Noida, U.P. on 11.11.2018 having roll number 120108920126 for selection to the post. The biometric impression of face & thumb of said Mr. Sunil Dangi was captured at examination centre at the time of entry to examination centre and exit from examination centre.

And whereas, said Mr. Sunil Dangi was shortlisted under zone of consideration of candidate finally selected to the post of Assistant Teacher (Primary), Directorate of Education, Govt. of Delhi. Accordingly, his dossier was forwarded by this board to User Department i.e., Directorate of Education, Govt. of Delhi, for taking further necessary action in the process of recruitment.

And whereas, said Mr. Sunil Dangi was appointed as Assistant Teacher (Primary) in User Department where his biometric examination was conducted to verify the genuinity of candidate appointed in User Department.

And whereas, the above biometric data of Mr. Sunil Dangi was found mismatching with the data of biometric examination procured on the day of his computer based test which tantamount that candidate appeared in the computer based test and candidate performing government service in User Department are different candidate as it is a universal fact that finger print impression of two or more persons cannot be same.

And whereas, upon receipt of above biometric mismatch report, the services of said Mr. Sunil Dangi was issued notice of termination of service under Rule 5(1) of CCS (TS) Rules, 1965 on 05.08.2022 followed by order of termination dated 06.09.2023 by User Department and subsequently this board vide order dated 02.05.2024 has debarred him from appearing in DSSSB examination for life time.

And whereas, said Mr. Sunil Dangi challenged the notice of termination of service dated 05.08.2022 & order of termination dated 06.09.2023 issued by User Department as well as debarment order issued by this board before the Central Administrative Tribunal, New Delhi under O.A. No. 2212/2024 titled as Sunil Dangi Vs The Chief Secretary, Govt. of Delhi & Ors..

And whereas, above said O.A. was decided by Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi on 29.01.2026 setting aside the notice of termination of service dated 05.08.2022 & order of termination dated 06.09.2023 by User Department as well as debarment order dated 02.05.2024 issued by this board by providing a liberty to this board to consider the matter afresh but only after putting the applicant to notice.

And whereas, above stated mismatch of biometric examination indicates that above named candidate has arranged some other person to appear in his behalf at computer based test so that he may get success in the examination and to be figured under merit list of selected candidates so as to be appointed as Assistant Teacher (Primary) in User Department. Thus, it is a prima facie case of impersonation which needs to be dealt strictly to punish the wrong doers as well as to mark an indicative lesson for other wrong doers.

And whereas, this board adheres to zero tolerance policy towards any misconduct by any candidate or any persons appearing in examination conducted by DSSSB including the act of impersonation which also attracts other phenomena of criminal activities like cheating, fraud and pecuniary loss to government etc.

And whereas a show cause notice is issued to said Mr. Sunil Dangi on 25.03.2026 for abovesaid impersonation and served to him through speed post (ED536650205) at the address mentioned by him in abovesaid O.A. as well as in his application form for applying for appointed as Assistant Teacher (Primary) in User Department but postal department returned the postal envelope with remarks "बार बार पूछने पर

कोई नहीं मिला". Further, notice is also served through his e-mail address mentioned in abovesaid application form but the said e-mail could not be delivered showing remarks "Address not found". On making efforts to contact the candidate on his mentioned telephone No. # 9671962012, the said number was found not responding.

And whereas, in continuation of earlier show cause notice dated 25.03.2026, a reminder show cause notice dated 22.04.2026 is issued to said Mr. Sunil Dangi directing to submit detailed explanation in writing within fifteen days of receipt of said reminder show cause notice as to why his case may not be considered for strict punitive action such as debarment from appearing in forthcoming examination as well as registration of FIR against him with the concerned law enforcement agencies for his above cited ill acts. It is also added in the said notice dated 22.04.2026 that if said Mr. Sunil Dangi fails to submit satisfactory reply within stipulated time, the matter will be decided as ex-parte on the basis of available information.

And whereas, above named candidate Mr. Sunil Dangi replied on 29.04.2026, the contents of clarification furnished by him in respect of above show cause notice served to him is as under :-

"He also state that an FIR has already been lodged against him by the Education Department and as per data available on the Board Website, he has already been debarred for lifetime by the DSSSB. Further, He reiterate that the action taken by the Concerned Authorities has caused unexplainable servere damage to him and his family."

And whereas, perusal and examination of above said reply of above named candidate reflects that he has no words to justify as to why different biometric impression of his face and finger occurred at the occasion of his computer based test (CBT) and cross verification upon joining of his service in user department. Moreover, he is silent on issue of punitive action as mentioned in show cause notice, in case of unsatisfactory reply.

Therefore, in view of above facts and circumstances and available record, it is concluded that above named candidate has committed the offence of impersonation and accordingly to be dealt with as per the prevailing practice of this board. This Board adheres to ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT by any candidate or any persons appearing in examination conducted by this board. Thus, above named candidate, Mr. Sunil Dangi (DoB : 18.10.1991) s/o Sh. Rohtash Dangi r/o Village Madina (Korsan), Tehsil : Meham, Distt. : Rohtak (Haryana), post code 89/17 of advertisement No. 04/2017 dated 20.12.2017 issued by this board, for the post of Assistant Teacher (Primary) in Directorate of Education, Govt. of Delhi, appeared in computer based test at IoN Digital Zone - 2, IDZ-2, Sec 62, Noida, U.P. on 11.11.2018 under roll number 120108920126 be debarred from appearing in any examination conducted / to be conducted by the DSSSB for lifetime w.e.f. 02.04.2025 i.e., date of filing of application for above post code & further, his candidature will be deemed cancelled if he had appeared in any exam conducted by DSSSB prior to above date.

This issues with the prior approval of the Chairman, DSSSB.
