Subject:- Uploading of documents and filling up of e-dossier by the shortlisted candidates for the posts/post codes of Junior Engineer (Civil) (04/12, MCD), (06/12, DAMB), (64/13, NDMC), (66/13, DJB), 67/13, DAMB) & (69/13, MCD).

The shortlisted candidates for the post of Junior Engineer (Civil), post code 04/12, 06/12, 64/13, 66/13, 67/13, & 69/13 are hereby requested to download the Preference Form and upload the same alongwith all the documents of Educational/Professional Certificates/Degree and Mark sheets/Disability Certificate/Caste Certificate/Proof of Govt. Servant/Ex. Servicemen, Admit Cards etc., as applicable in their e-dossier available in the DSSSB module.

The e-dossier module shall be opened for uploading of documents on **06.09.2017**. The last date of uploading the documents has been fixed on **20/09/2017**. The candidate must fulfil all the eligibility criteria as on the cutoff date i.e. **15.06.2012** (for post code 04/12 & 06/12) & **18.10.2013** (for post code 64/13, 66/13, 67/13 & 69/13).

- Note: 1.** OBC (outsider) candidates have been treated as UR candidates.
- 2.** The candidate who has been shortlisted in more than one post code should fill the preference form with identical order of preferences and in case the candidate gives different order of preferences in different preference forms then preference forms so filled shall be ignored by DSSSB and the candidates will be assigned the post/post codes (In case of his /her selection) as per availability of vacancies as if no preference has been filled.

Mere asking the candidates for uploading documents in the e-dossier module does not entitle them for selection to the post. It is also clarified that the candidates who fail to upload their documents on or before the date as mentioned above will not be given any further opportunity and their candidature will be treated as cancelled.
