SPECIAL EDUCATOR, POST CODE-15/17 IN MUNICIPAL CORPORATION OF DELHI

The DSSSB vide its advertisement No. 02/2017 dated 07/08/2017 had advertised total 1540 [UR-773, OBC-426, SC-226, ST-115 (including PH/OH-24 & PH/VH-25) for the post of **Special Educator under Post code-15/17** in MCD with closing date as 15.09.2017. Tier-I examination in online computer based examination mode was conducted on 22.07.2018.

- 2. On the basis of online examination of Tier-1 held on 22.07.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.02/2017 and RRs for the post of Special Educator, Post Code-15/17 in MCD, a total of 445 (UR-281, OBC-47, SC-105, ST-12 including PH-20) were provisionally nominated vide Result Notice No.354 dated 25.02.2019 & Supplementary Result Notice No. 479 dated 12.07.2019
- 3. Further, the candidature of 128 candidates were rejected for not having the requisite qualification/age etc. for the post of Special Educator Post Code 15/17 vide Rejection Notice No. 352 dated 23.02.2019, Rejection Notice No. 477 dated 12.07.2019, Rejection Notice No. 478 dated 12.05.2019. Out of these 128 candidates who were rejected for not having requisite qualification / age, a total of 53 candidates (UR-34, OBC-10, SC-05, SC/PH/OH-01, ST-03) were rejected for not having CTET qualification as on last cut off date & another 07 candidates (UR-01, OBC-03, SC-01, ST-02) for being overage. These candidates, however, went to the Hon'ble Court for seeking relief with regard to CTET qualification OR relaxation in age in various O.As.
- 4. Now the South Delhi Municipal Corporation vide their communication bearing No.D/DDE/Admin/Edu./HQ/SDMC/2020/93 dated 08/07/2020 has communicated to the Board as follows "... in compliance of the direction passed by the Hon'ble High Court of Delhi dated 21.03.2019 in W.P. (C) No. 9040/2019 titled Praveen Khatri and Ors Vs. Govt. of NCT of Delhi & Ors, the Education Department of Sough Delhi Municipal Corporation had sent a proposal to the Hon'ble Lt. Governor, Delhi through Director (Local Bodies) to grant relaxation as per power confirmed in Clause 5 of RRs to the post of Special Educator (Primary) in Municipal Corporation of Delhi (2012) (South, East and North Delhi Municipal Corporation) in the following matters —

1. To consider the CTET qualification of the candidates who are otherwise qualified and obtained the CTET qualification after the cut

off date but before their appointment to the post of Special Educator (Primary) under post code15/17.

2. To relax the age of candidates who are otherwise qualified for appointment to the post of Special Educator (Primary) under post code 15/17.

In this regard, Hon'ble Lt. Governor, Delhi has granted one time relaxation of age and CTET qualification to the otherwise qualified candidates who have obtained the CTET qualifications after the cutoff date but before their appointment and age relaxation even if they may have become overage for the post of Special Educator (Primary) as advertised vide post code no.15/17.

Further, grant of age relaxation to the candidates, otherwise eligible, has been considered on same lines as done by Education Department, GNCTD recently for Special Education Teachers vide order has been considered vide No. F. 209/DDE (IEDSS)/Court File/2016-17/CD No. 043457883/9831-37 dated 06.12.2019.

This shall not be treated as precedent for any future recruitment for the post or any other posts.

The Office Order in this regard has been issued by Dy. Director (Local Bodies vide No. F. CD No. 000583201/18194-18198 dated 13.03.2020......"

6. In pursuance of Notice No. 661 dated 04/09/2020, rescinding the earlier rejections in respect of those candidates having CTET after cutoff date or being overage, the following 08 candidates (UR-01, OBC-03, SC-02, ST-02) have been provisionally nominated in continuation to Result Notice No. 353 dated 23.02.2019, Supplementary Result Notice No. 354 dated 25.02.2019 & Supplementary Result notice No. 479 dated 12.07.2019 who had been earlier declared "Not Eligible" for being 'Overage' by giving onetime relaxation in age even if they may have become Overage, in accordance with aforementioned communication dated 08.07.2020 issued by SDMC and on the basis of offline written examination of Tier-1 held on 22/07/2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.02/2017 and RRs for the post of Special Educator, Post Code-15/17 in MCD.

- 7. The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 8. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 9. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the

candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

- 10. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 12. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 13. The candidature of the following 07 candidates whom candidature was kept pending for want of deficient / requisite documents are being given 05 days 2nd and final opportunity to upload the deficient documents in the e-dossier:-

14. The candidates referred at para-13 above are being given 2nd and final opportunity to upload the deficient documents in the e-dossier w.e.f. 08/09/2020 to 12/09/2020, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground.

- **16.** The result process for the above post code stands closed in all respect except 59 vacancies which have been kept pending for want of deficient documents as referred at para-13 & 16 above.
- 17. Waiting panel for post code-15/17 has already been expired on 24.02.2020 as per earlier Result Notice no. 354 dated 25.02.2019.
- 18. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
