GENERAL INSTRUCTIONS TO CANDIDATES FOR DRIVING SKILL TEST OF POST CODE-39/20, DRIVER, SDMC/MCD

- 1. Specific Date and Reporting Time of Skill Test of a candidate is given in his Admit Card.
- 2. The candidate must report at the Test venue strictly as per reporting time given in e-admit Card along with requisite documents. No entry will be allowed after reporting time or without requisite documents under any circumstances.
- 3. Photo Attendance Sheets will be provided at the center and the same is to be handed over to the invigilator on the exam day after signing, affixing thumb impression and after completing writings in the presence of invigilator. Candidates are allowed to take back home 1st page of Admit Card after the completion of exam. A candidate, under no circumstances shall be allowed to leave exam center before time of completion of exam.
- 4. Candidate should bring original e-admit card along with one Valid Government photo ID proof (in original) containing clear photograph of the candidate, which could be verified with the face of the candidate. Mutilated/very old ID cards from which candidate could not be verified, will not be allowed to enter the exam venue. No request/plea will be entertained in this regard.
- 5. Candidate should bring valid original HMV Driving License issued by Competent Authority at Driving Skill Test Centre on the date mentioned on eadmit card otherwise he will not be allowed to enter the exam venue. The HMV Driving License should be issued on or before 20.02.2015 and should be valid on the day of his skill test. No further request in this regard will be entertained under any circumstance.
- 6. The candidature of the Driving Skill Test is provisional. The candidates should satisfy themselves regarding possession of the required qualification, age, caste and admissibility of benefit of reservation etc. as stipulated for the post he has applied for, as on the cut off date, before appearing in the examination. The candidature will be treated as debarred, **invalid**, *ab-initio*, in case he does not fulfill the eligibility criteria.
- 7. The candidate should not bring any articles at the test venue except mentioned in the admit card.
- 8. Travelling and other expenses shall be borne by the candidates themselves. The Board does not make any arrangements for the lodging and boarding of the candidates.
- 9. In presence of Invigilator Candidates should write their particulars wherever required and should put their signature at the space provided. Candidate should put his left hand thumb impression on the space provided in the Admit Card/ Photo Attendance Sheet in the presence of the invigilator. Thereafter, the invigilator will sign on the Admit Card/ Photocopy Attendance Sheet.
- 10. Candidates must abide by the further instructions, which may be given to them by the Centre Supdt. /Instructors/Invigilators/board staff etc. If any candidate fails to do so or indulges in disorderly or improper conduct he will render himself liable to expulsion from the Test as well as other penalty as the Board may deem fit to impose.

- 11.If any candidate is found using any unfair means, conspiracy, cheating, fraud, forgery, impersonation or any unlawful act he will be debarred from all examinations of DSSSB and necessary legal action will be initiated.
- 12. The candidature of the candidate to the Driving Skill Test is entirely provisional and subject to the outcome of any direction/decision/order/pronouncement of any court of law and mere issue of admit card or appearance at Examination/Test/ Skill Test does not entitled him any claim for the post.
- 13. The Board reserves the right to cancel a part of or entire process of examination/test due to administrative reason(s) and in case of unfair means, cheating or other irregularities/malpractice noticed by the Board. The Board also reserves the right to cancel or set up a new examination center and divert the candidates to appear at that examination center if required.
- 14. The decision of the Board in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s) and allotment of examination centers, selection and allotment of posts/organizations to selected candidates will be final and binding on the candidates and no enquiry/correspondence will be entertained in this regard.
- 15. The Board reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment. Further, candidature of every candidate is purely provisional, at every stage until he is offered appointment by the concerned Department to which the post belongs, after due verification of documents and eligibility in respect of the post.
- 16. <u>Prohibited Items for Candidates in the Exam.</u> The candidates are not allowed to carry any communication device like Mobile Phone etc. and any other items which may cause hindrance to conduct of examination.
- 17. No arrangement will be made at the Centres for Keeping any articles/items belongings to the candidates.
- 18. Candidates are directed to follow all COVID-19 related safety measures including wearing masks, social distancing, respiratory hygiene etc.
- 19. Candidates will be allowed to carry only the following items with them into the examination venue:
 - **i.** Original and 02 Photocopies of valid HMV Driving License issued on or before 20.02.2015.
 - ii. Original and 02 Photocopies of Aadhaar Card/ Other Govt. issued Photo IDs.
 - iii. Three Colour Passport Size Photographs.

iv. Original Admit Card.
