ORDER

Sub:- Compliance of the order dated 27.05.2014 of LD. CAT in OA. 1855/2014 titled Smt. Sarika Vs DSSSB & Ors.

The Hon'ble CAT in OA No. 1855/2014 titled Smt. Sarika V/s DSSSB & Ors vide its order dated 27.05.2014 has directed as under:-

"4. In the circumstances, the OA is disposed of, at the admission stage itself, without going in to the other merits of the case, by directing the respondents to consider the representation of the applicant and to pass an appropriate reasoned and speaking order thereon, within eight weeks from the date of receipt of a copy of this order. No order as to costs."

In compliance of the above order, the case of applicant Smt. Sarika (Roll No. 01614672) has been examined, wherein she has stated being a member from schedule Tribe category and having all the eligibility criteria had applied for the post of Primary Teacher. And after having gone through the representation dated 14.02.2014 carefully and taking all the facts in consideration in totality, it is found that:-

1. The applicant Smt. Sarika had applied for the post of Teacher (Primary) in MCD, under post code No.016/08, under ST category. The DSSSB had conducted the examination for this post on 15.02.2009 and final result for the post code was declared on 06.10.2009.

2. The petitioner was shortlisted in ST category in part-I exam, and she secured 68/200 marks in part-II examination, which was below the minimum qualifying marks (35%) fixed for reserved category in part-II (Descriptive paper) for the post as per the terms and conditions of advertisement for the post.

In view of the above facts, the applicant Smt. Sarika is not considered for selection to the post of Teacher (Primary) in MCD, under post code 016/08.

This issues with prior approval of the competent authority.
