SUPPLEMENTARY RESULT NOTICE NO: 1054 FIRE OPERATOR IN DELHI FIRE SERVICES, UNDER POST CODE-71/14

- 1. This is in continuation of the Result Notice No. 861 dated 25.11.2019.
- 2. The DSSSB, vide its advertisement No. 01/14 had advertised 803 vacancies (UR-290, OBC-126, SC-282, ST- 105) for the post of Fire Operator in Delhi Fire Service under Post Code 71/14. The closing date of application /cut off date was 27.02.2014. An addendum was issued on 26.05.2015 vide which the vacancies had been increased from 803 to 841 vacancies (UR-321, OBC-126, SC-288 & ST-106) under post code 71/2014 in DFS. Board has conducted written test for this post on 31.08.2014, thereafter Physical Endurance Test was conducted by DSSSB from 17.06.2016 to 29.06.2016 and driving skill test was conducted by DFS from 01.09.2017 to 22.09.2017.
- 3. On the basis of the marks scored by the candidates in written test, PET & Driving skill test and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, DSSSB declared Result Notice No. 606 dated 16.11.2017 and subsequent supplementary Result Notices No. 724 dated 10.10.2018, No. 763 dated 15.02.2019 and no. 861 dated 25.11.2019.
- **4.** The result has been processed keeping in view of the eligibility conditions regarding educational qualifications / caste certificate / disability certificate etc. as on cut off date i.e. 27.02.2014 for post code-71/14.
- **5.** Accordingly in continuation to above result notices and on the basis of marks secured in written examination and after preliminary scrutiny, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidates are provisionally selected from the waiting panel for the post of Fire Operator under post code 71/14 in DFS, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application forms and e-dossiers:-



- 7. The candidates mentioned at SI. No. 04 in par 06 above is directed to upload his all requisite / applicable documents etc. if any, through the e-dossier module in stipulated time failing which his candidature will be rejected without any further notice. The e-dossier link shall be active from 06.03.2020 to 15.03.2020. If, the candidate fails to upload required documents through e-dossier during the above said period his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 8. The provisional selection of the above total 25 (Twenty five) candidates [UR-16 & OBC-09] shall be further subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/ handwriting etc. On the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate. The Competent Authority of the Department concerned shall issue the offer of appointment to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- **9.** Note: It is stated that the recognition of the Board/Authority /Institution from which the certificates/driving licence to drive Heavy Duty Vehicles etc. have been issued and as submitted by the candidates must be verified thoroughly by the Delhi Fire Service at their own level before issuing offer of appointment. In respect of candidates whose particulars as recorded in application form for the post varies to the particulars as indicated in the Driving Licence, the Board nominating the candidates to

the post with clear stipulation that veracity of Driving Licence of such candidates shall be got verified from the RTO concerned by DFS before issuance of offer of appointment.

- duty vehicles in respect of some candidates was not clear in as much as the date of issue of driving licence in many cases is prior to the cut off date but the date of renewal of the driving licence is after cut off date and from reading of the photocopy of the driving licence, it is not clear as to from which date the said candidates are eligible for driving heavy duty vehicles. Therefore, DFS is directed to specifically check the date since when the above mentioned candidates are eligible for driving heavy duty vehicles with respect to the cut off date specified by DSSSB i.e. 27.02.2014 as DSSSB is not undertaking scrutiny/veracity on these issues as these can be best clarified by the issuing authority of the Driving licence before issuance of offer of appointment.
- 11. Delhi Fire Service is directed to obtain and verify the Driving Licence (issued before cut off date i.e. 27/02/2014) for driving heavy duty vehicles in r/o each candidate. The validity, correctness and genuineness of the Driving Licence as mentioned above may also be checked from the issuing authority by DFS. The provisional selection of 25 candidates as mentioned above is also subject to verification of the identity of the candidate w.r.t. their photographs, signatures /handwriting etc. by the User Department i.e. Delhi Fire Service.
- 12. The Competent Authority of User Department shall satisfy himself/herself of eligibility of candidates as laid down in the Recruitment Rules and verify the correctness/genuineness of the information /documents/caste certificate/Driving Licence for Heavy Motor Vehicle furnished by the candidates.
- 13. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The user Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the



candidate. The User Department is also requested to rectify/ correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 14. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidates in the light of Notification No. 36012/22/93-Esttt.(SCT)dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the user department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.
- 15. User Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 16. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 17. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt Issued from time to time.
- 18. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- The recruitment process for the post code-71/14 had already been closed subject to disposal of above pending cases and subject to outcome of pending court cases, if any.
- 20. The marks of last provisionally nominated candidates in each category after this result are as follows:-
