Reference Notice No. F. No. 288/Result/TGT (Sanskrit)/Male//CC-III/DSSSB/2021-22/3474-82 dated 15.12.2021, the shortlisted candidates for the post of TGT (Sanskrit), Male, Post Code-54/21 were asked to upload their documents in the e-dossier w.e.f. 21/12/2021 to 04/01/2022.

2. On scrutiny of the documents uploaded by the candidates in the e-dossier, it has been noticed that some of the candidates have uploaded their e-dossier with deficient documents. Therefore, the following candidates are being given 1st opportunity w.e.f. 05/04/2022 to 14/04/2022 to upload the deficient/requisite documents in the e-dossier as mentioned against their roll numbers:-

1	113905400153	The candidate has uploaded marks sheets in Shastri only. Therefore, the candidate is directed to upload (i) B.Ed. degree & its marks sheets. (ii) CTET certificate & its marks sheet. (iii) 10 th certificate & marks sheet. (iv) 12 th certificate and marks sheet. (v) documents regarding knowledge of Hindi in the e-dossier.
2	113505400054	The candidate is Overage 10 months 18 days. He has applied under PHOB category but not uploaded any supporting documents i.e. PH certificate. He has uploaded an affidavit stating that due to technical error, he had applied PHOB ctgy. inadvertently and not belonging to this category. The candidate is directed to upload relevant documents for taking relaxation in age.
3	112705400265	The candidate has not uploaded any documents regarding knowledge of Hindi. As per RRs, Knowledge of Hindi is essential requirement for the post. The candidate is directed to upload relevant documents regarding knowledge of Hindi.
4	121205400245	The candidate has qualified CTET with 86 marks by taking relaxation in marks under OBC ctgy. but applied under UR ctgy. Hence, the candidate is directed to upload CTET qualified certificate without relaxation required.
5	121205400819	The candidate has qualified CTET with 85 marks by taking relaxation in marks under OBC ctgy. but applied under OBC (OS) ctgy. Hence, the candidate is directed to upload CTET qualified certificate without relaxation required.
6	121105400001	The candidate is overage by 01 year 8 months 8 days. He has applied under DGS ctgy. However working in western central railway as P/ Man. As per DoPT guidelines/ instruction dated 27 th march, 2012, 05 years relaxation in age to departmental candidate with atleast 03 years continuous services is applicable for group B post which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of post. The candidate is directed to upload the relevant documents for taking relaxation in age.
7	121205400538	(i) As per marks sheet uploaded by the candidate it has been noticed that B.ed. first year done in May, 2020 and second year done in may, 2019. The

		candidate is directed to submit a clarification in this regard. (ii) Further, OBC (Delhi) certificate required in the e-dossier.
8	111605400249	OBC certificate issued on the basis of his father resident of Bihar which is considered as OBC (Outsider). The candidate is directed to upload OBC (D) certificate as on cutoff date which notified by Govt. of NCT of Delhi as per details/clarification given at para-6 of advertisement No. 03/2021.
9	111605400129	OBC certificate issued from Uttar Pradesh which is considered as OBC (Outsider). The candidate is directed to upload OBC (D) certificate as on cutoff date which notified by Govt. of NCT of Delhi as per details/clarification given at para-6 of advertisement No. 03/2021.
10	112005400172	The candidate has applied under PHSC category but not uploaded any documents of PH category. Hence, he is directed to upload PH certificate in the e-dossier.
11	112805400164	The candidate is overage by 09 years 06 months 25 days. However, by giving 05 years relaxation in age being SC category & 01 year relaxation of GCT ctgy, he is still overage by 03 years 06 months 25 days. Hence, the candidate is directed to upload relevant documents for taking relaxation in age.
12	121205400729	The candidate has applied under PHSC category but not uploaded any documents of PH category. Hence, he is directed to upload PH certificate in the e-dossier.
13	121205400530	Documents regarding knowledge of Hindi required in the e-dossier.
14	113705400043	The candidate has applied under PHSC category but not uploaded any documents of PH category. Hence, he is directed to upload PH certificate in the e-dossier.
15	111305400080	The candidate has uploaded diploma in elementary education whereas B.ed. required instead of D.El.Ed. The candidate is directed to upload B.Ed. degree and its marksheet in the e-dossier.
16	111105400080	The candidate is 01 year 02 months 08 days overage after giving 05 years relaxation in age under ST category. The candidate is directed to upload complete / proper documents regarding DGS category for taking relaxation in age.
17	112705400258	CTET qualified certificate & marks sheet required in the e-dossier.
18	113505400054	The candidate has applied under PHOB category but not uploaded any documents of PH category. Hence, he is directed to upload PH certificate in the e-dossier.
19	111605400007	CTET certificate & marks sheet required.
20	111605400032	B.A. (Hindi) with Sanskrit as additional subject whereas B.A. (Honours) or B.A. with Sanskrit subject required as per RRs. the candidate is directed to upload B.A degree in Sanskrit & its marks sheet.
21	121105400743	PH certificate not uploaded. The candidate is directed to upload PH certificate as on cut off date.
22	112705400005	The candidate has applied under PHSC category but not uploaded any documents of PH category. Further, CTET qualified certificate required. Hence, he is directed to upload PH certificate & CTET qualified certificate and its marks sheet in the e-dossier.

3. The above 22 candidates are being given 1st opportunity w.e.f. 05/04/2022 to 14/04/2022.

4. The e-dossier link shall be activated to the above 22 pending candidates only for a period of 10 days w.e.f. 05/04/2022 to 14/04/2022.

5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **03/07/2021** as per Advertisement No. 03/2021.

6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
