## TGT (COMPUTER SCIENCE) POST CODE-192/14 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No. 01/2014 had advertised total **2026** [UR-1025, OBC-547, SC-303, ST-151 including OH-20, HH-20, VH-20] vacancies for the post of **TGT** (**Computer Science**), **Post Code-192/14 in Directorate of Education** with closing date as 27.02.2014. Tier-I examination in offline written examination mode was conducted on **21.05.2017**.

- On the basis of marks secured in the written examination and after preliminary 2. scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, 1649 Candidates (UR-924, OBC-371, SC-276, ST-78 including 13 OH, 02 HH, 01 VH) were provisionally nominated vide Result Notice No. 183 dated 11.09.2017, 186 dated 15.09.2017, 187 dated 15.07.2017, 188 dated 20.09.2017, 189 dated 2309.2017, 190 dated 27.07.2017 & 191 dated 28.09.2017 for the post of TGT (Computer Science), Post Code-192/14 in Directorate of Education and 128 candidates (UR-84, OBC-28, SC-12, ST-04 including 05 PH/OH) were provisionally nominated vide Supplementary Result Notice No. 182, 193, 194, 195 & 196 dated 11.10.2017. The candidature of 12 candidates (UR-11, SC-01) was withdrawn vide notice No. 200 & 201 dated 25.10.2017 due to court case candidates. Further, 58 candidates (UR-15, OBC-30, SC-11, ST-02) were provisionally nominated vide Supplementary Result Notice NO. 208 dated 10.11.2017 and 09 candidates (UR-07, OBC-01, SC-01) were provisionally nominated vide Supplementary Result Notice no. 249 dated 04.05.2018. The candidature of 11 candidates (UR-07, OBC-03, SC-01) was withdrawn due to cancellation of their candidature/shifting from UR to their respective category. Further, 18 candidates (UR-02, OBC-04, SC-05 including 02 PH/OH) were provisionally nominated vide Supplementary Result Notice No. 249 dated 04.05.2018, 250 dated 15.05.2018 & 262 dated 22.06.2018. Furthermore, the User Department vide letter dated 29.06.2018 had returned 42 dossiers (UR-27, OBC-02, SC-09, ST-04) of the candidates who failed to report for verification of documents in the User Department and accordingly, Accordingly, 37 candidates (UR-27, SC-09, ST-01) candidates in waiting panel below the merit were considered as per availability of the candidates in the merit in their respective category.
- 3. Further, in compliance of the direction of the Hon'ble CAT in O.A. No. 4463/2017 in the matter of Kusum Lata Vs. Govt. of NCT of Delhi, the candidature of one candidate under OBC category is being considered for provisional nomination for the post of TGT (Computer Science), Post Code-192/14 in Directorate of Education.
- 4. Accordingly, in continuation of Result Notice No. 183 dated 11/09/2017, Result Notice No. 186 dated 15/09/2017, Result Notice No. 187 dated 15/09/2017, Result Notice No. 188 dated 20/09/2017, Result Notice No. 189 dated 23/09/2017, Result Notice No. 190 dated 27/09/2017, Result Notice No. 191 dated 28/09/2017, Result Notice No. 192 dated 11/10/2017, Result Notice No. 193 dated 11/10/2017, Result Notice No. 194 dated

- 5. The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which he/she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his/her identity with reference to his/her photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his/her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates erified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
  - 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt, of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
  - 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
  - 11. The recruitment process for the above post code has already been closed in all respect except 12 vacancies which have kept pending for court case candidates.
  - 12. The waiting panel which was valid for a period of one year from the date of declaration of result i.e. upto 10.09.2018 as per earlier Result Notice No. 183 dated 11.09.2017.
  - 13. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
