## TGT (SOCIAL SCIENCE) MALE POST CODE-12/13 IN DIRECTORATE OF EDUCATION

1. Whereas Mr. Amit Kumar Jha has filed an O.A. No. 1332/2018, titled as Amit Kumar Jha Vs. Govt. of NCT of Delhi & Ors. and the Hon'ble CAT has disposed off the said O.A. vide order dated 11.02.2020 wherein the operative part is as under:-

"We set aside the speaking order and Rejection Notice No. 48 and direct the respondents to consider the appointment of the applicant in view of the order dated 02.04.2018 and also take consequential action within six weeks from the date of receipt of a certified copy of the order, O.A. is disposed of".

- 2. Whereas, Sh. Amit Kumar Jha had applied for the Post of TGT (Social Science) Male Post Code-12/13 advertised by Advertisement No. 01/13. The applicant, **Sh. Amit Kumar Jha (Roll No. 54100568)** scored 97.25 marks in the written examination for the Post of TGT (Social Science) Male, Post Code-12/13 and appeared for documents verification. The candidate in addition to the documents in support of his educational qualification has submitted marks sheet and provisional degree of B.Ed. issued by IGNOU.
- 3. Whereas, on scrutiny of the marks sheet and provisional B.Ed. degree of the candidate, it was noticed that the same were issued on 06.04.2013. Since the date mentioned in the marks sheet as well as provisional B.Ed. degree of Sh. Amit Kumar Jha was after the closing date of receipt of applications, i.e. 20.03.2013, his candidature was rejected vide Rejection Notice No. 48 dated 27.07.2016 for not fulfilling the eligibility conditions as mentioned in para-5 of advertisement No. 01/13.
- 4. Whereas, Sh. Amit Kumar Jha approached the Hon'ble CAT vide O.A. No. 2433/2017 and the Hon'ble CAT vide order dated 25.07.2017 had disposed of the O.A. and directed "to consider the representation dated 29.07.2016 & 06.09.2016 of the applicant by duly keeping in view the B.Ed. degree certificate dated 04.02.2013

and clarification letter dated 28.07.2016 of the University and to pass appropriate reasoned and speaking orders thereon within thirty days from the date of receipt of a certified copy of this order, in accordance with law". Therefore, in compliance of the direction of the Hon'ble CAT in O.A. No. 2433/2017, considering the representations of the applicant, the speaking order dated 22/03/2018 was issued that "there is no need for review of the decision already taken regarding rejection of his candidature".

- 5. Whereas, the candidate, Sh. Amit Kumar Jha again approached the Hon'ble CAT vide O.A. No. 1332/2018 and the Hon'ble CAT vide order dated 11.02.2020 had directed to consider the appointment of the applicant in view of the order dated 02.04.2018 and also take consequential action within six weeks from the date of receipt of a certified copy of the order.
- 6. Whereas, now Hon'ble CAT has disposed off O.A. No. 1332/2018 vide order dated 11.02.2020 as reproduced in para 1 above of this notice, directing to consider the appointment of the applicant in view of the order dated 02.04.2018. The candidate has now approached the Hon'ble CAT seeking contempt proceedings against the Board for having failed to implement the orders dated 11.02.2020, as detailed in para -1 of the notice herein above.
- Now, therefore, in compliance of the Hon'ble CAT order dated 11.02.2020 in O.A. No. 1332/2018, titled Amit Kumar Jha Vs. Govt. of NCT of Delhi & Ors., the candidature of Sh. Amit Kumar Jha (Roll No. 54100568) rejected vide Rejection Notice No. 48 dated 27/07/2016 issued vide F. No. (58)/TGT (Social Science) Male/Result-2013/Int. Cell/DSSSB/2016-17/289 dated 27/07/2016 is hereby revived and further Sh. Amit Kumar Jha (Roll No. 54100568) is hereby provisionally nominated under UR category for the post of TGT (Social Science) Male, Post Code-12/13 in Directorate of Education.
- 8. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to his photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information

furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- 9. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 11. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 12. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the

original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

- 13. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 14. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 15. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage or arising due to court cases., if any.
