ASSISTANT TEACHER (NURSERY), POST CODE-16/19 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No. 03/19 dated 05.09.2019 had advertised total 141 [EWS-8, UR-77, OBC-26, SC-21, ST-09 including PH-11] vacancy for the post of Assistant Teacher (Nursery) in Directorate of Education, Post Code-16/19 with closing date as 15/10/2019. Further, vide addendum to advertisement no. 03/20019 for post code-16/19 dated 15/11/2019, the vacancies of the aforesaid post code had been revised as 265 (UR-128, EWS-20, OBC-73, SC-21, ST-23 including PH/OH-05, PH/VH-09) and thereafter, vide corrigendum dated 24.09.2020, the number of vacancies have been revised as 265 (UR-122, EWS-26, OBC-73, SC-21, ST-23 including PH/OH-05, PH/VH-09). Tier-I examination in online mode was conducted on 19/11/2019.

- On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the 2. terms and condition of the advertisement, a total 138 Candidates [(UR- 59, EWS-15, OBC-43, SC-12, ST-09 including 09 PH (OH), PH(VH)] were provisionally selected for the post of Assistant Teacher (Nursery), Post Code-16/19 in Directorate of Education and 115 Candidates [(UR- 57, EWS-08, OBC-33, SC-11, ST-06 including 03 PH] were provisionally nominated vide Supplementary Result Notice No. 805 dated 16.08.2021 and 12 vacancies were kept pending for want of deficient documents in the e-dossier.
- Further, the user Department i.e. Directorate of Education vide their letter dated 25.06.2021, 31.08.2021, 30.09.2021, 10.09.2021, 25.10.2021 & 29.11.2021 had returned 57 dossiers (UR-28, EWS-09, OBC-09, SC-07, ST-04) of those candidates who did not join their duties in the User Department. All the dossiers were returned before expiry of waiting panel i.e. 19.11.2021 except two dossiers which received after expiry of waiting panel i.e. 29.11.2021 and hence, 55 vacancies have been created and the candidates in waiting panel are considered for nomination against created vacancies. As per existing available merit list of the qualified eligible candidates, the candidates in waiting panel are being considered for provisional nomination for the post of Assistant Teacher (Nursery), post Code-16/19.
 - Accordingly, in continuation of Result Notice No. 706 dated 19.11.2020 & Supplementary Result Notice No. 805 dated 16.08.2021, the candidates, as detailed below, are also provisionally selected on the basis of online examination of Tier-I held on 19/11/2019 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.03/19 and RRs for the post of Assistant Teacher (Nursery), Post Code-16/19 in Directorate of Education subject to their fulfilling all other conditions of



eligibility and also correctness of the information furnished by the candidate in their online application forms and e-dossier:-

- The user department is requested to thoroughly verify the certificates of Nursery Teacher's Training course uploaded by the candidates in the light of National Council for Teachers Education's instructions/guidelines issued from time to time before issuance of any offer of appointment. The user department is further requested that if the candidate found not eligible, his/her dossier may be returned after cancellation of his/her candidature.
- The selection of the above 30 (UR-08 including 01 PH, EWS-07, OBC-09, SC-006) candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to

- their photographs, signatures/handwriting etc. on the application form, admission cartificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
 - 7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny documents of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
 - 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
 - 9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

- 10. The User Department shall also get the EWS certificates verified from the Issuing authority. Further, the User Department shall also verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority as per instruction of DoPT O.M. No. 36039/1/2019-Estt (Res) dated 31.01.2019.
 - 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
 - 12. The user department is further requested to ascertain the eligibility condition with regard to one time age relaxation to the Guest/Contract Teachers of Directorate of Education in pursuance of services O.M. No. F19 (11)/2015/S-IV/1751-1756 dated 11.06.2019.
 - 13. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
 - 14. The result process for the above post code stands closed in all respect except 02 vacancies (01 for court case & 01 for verification of candidature etc). Further, 45 vacancies are still vacant against return of dossiers received before expiry of waiting panel for which more qualified candidates below the merit in their respective categories are being shortlisted for uploading of e-dossier.
 - 15. Waiting panel was valid for a period of one year from the date of declaration of result i.e. upto 18.11.2021 as per Main Result Notice No. 706 dated 19.11.2020.
 - 16. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
 - 17. The category wise marks obtained by the last selected candidates have been given as under:-
