**ORDER**

This order disposes of the issues raised by **Mrs. Yasmeen (Roll No. 248091113000424)**, a candidate for the post of **TGT (Urdu) Male & Female in DoE** and **TGT (Urdu) in NDMC** under **Post Code 809/24**, and also the applicant in **O.A. No. 4295/2025** titled **Mrs. Yasmeen vs. DSSSB**.

The Hon'ble CAT, vide order dated **11/11/2025**, disposed of the O.A. at the admission stage itself, without going into merits, and directed as under:

*"4. In view of the prayer made by the learned counsel for the applicant, the competent authority amongst the respondents is hereby directed to dispose of the aforesaid representation of the applicant, by passing a reasoned and speaking order, within a period of thirty days from the date of receipt of a certified copy of this Order. A copy of the speaking order so passed be given to the applicant. It is made clear if the order is passed in favor of the applicant, consequential relief, if any, also be accorded to the applicants within a period of 45 days thereafter."*

**Applicant's Representation:-**

The applicant, vide her representation at Annexure-1 of the O.A., has stated that she had applied under Post Code 809/24 (combined examination), the examination for which was conducted on 13/10/2024. Vide Result Notice dated 18/08/2025, she was nominated to NDMC under the OBC category. However, during verification, she was informed that she did not possess an OBC-NCL certificate, which is mandatory.

She thereafter requested DSSSB to change her department and category from **NDMC (OBC)** to **DoE (UR)** on the ground that she had also qualified under the UR category in DoE. DSSSB declined this request. The applicant has further submitted that she continues to be eligible under the OBC-NCL category as her family income remains below the notified threshold. She has thus requested that she either be considered under the OBC category or her department be changed.

**Recruitment Details:-**

DSSSB vide Vacancy Notice/Advertisement No. 02/24 dated 12/01/2024 with closing date 08/03/2024, and Corrigendum No. 5070-81 dated 19/02/2024, advertised **626 vacancies** (UR-398, OBC-37, SC-126, ST-62, EWS-03, including Cat-A:05, Cat-B:05, Cat-C:04 & Cat-D&E:05) for recruitment to the post of TGT (Urdu) Male in DoE, TGT (Urdu) Female in DoE and TGT (Urdu) in NDMC under Post Code 809/24.

The **cut-off date** for determining educational qualifications, age, and all eligibility conditions was **08/03/2024**.

The Board conducted the One-Tier (Technical/Teaching) Examination on **13/10/2024**. Prorated marks of 1573 candidates who appeared were uploaded vide Notice No. 1548 dated 20/06/2025. Of these, 605 candidates were shortlisted for uploading documents in the e-dossier module and required to exercise at least one preference in OARS between 24/06/2025 and 08/07/2025.

As per provisions of Notice No. 1548 dated 20/06/2025, allocation of posts/departments is strictly on the basis of **merit-cum-preference**. Once a post/department is allocated, **no change is permitted**.

#### **Candidate's Details:-**

Mrs. Yasmeen (Roll No. 248091113000424) applied under **OBC (D) / WO** category, appeared in the Tier-I Examination on 13/10/2024, secured **97.97 prorated marks (out of 200)**, and was shortlisted for e-dossier submission. She submitted her preferences as:

1. **NDMC** (1st Preference)
2. **DoE** (2nd Preference)

Vide Result Notice No. 1556 dated 18/08/2025, she was allocated **NDMC (OBC-D)** on the basis of merit-cum-preference. The relevant cut-offs for TGT (Urdu) Female (DoE) and TGT (Urdu) (NDMC) are reproduced below:

Accordingly, she was nominated to NDMC under the OBC (D) category.

**Scrutiny of Eligibility in OBC Category in NDMC:-**

As per Board's Resolution dated 14/07/2022, DSSSB does not undertake scrutiny of documents uploaded in the e-dossier. Verification of eligibility as per the Recruitment Rules and advertisement conditions is the exclusive responsibility of the **User Department**, which, in this case, is **NDMC**.

Therefore, the applicant's request for consideration under the OBC (D) category **falls entirely within the jurisdiction of the User Department i.e., NDMC**, which must comply with the directions of the Hon'ble CAT by issuing a reasoned and speaking order within the stipulated timeframe.

**Regarding the Applicant's Request for Change of Department:-**

The applicant has also requested change of her allocated department from **NDMC (OBC)** to **DoE (UR)**.

This request has been examined in detail. The applicable provisions are as follows:

- a. **Corrigendum No. 5070-81 dated 19/02/2024** – Post Preference: Candidate must exercise at least one preference for a post. Candidates who do not submit their post preference(s) within the stipulated time, will not be considered for any post in the final result. Such candidates shall not be provided with another opportunity to exercise preference for posts.
- b. **Clause 6(ix) of Advertisement No. 02/24 dated 12/01/2024**: The final allotment of departments will be made on the basis of merit-cum-preferences of Departments of candidates. Once a department is allocated, no change of department will either be entertained or allowed by the Board.
- c. **Clause 6(xv) of Advertisement No. 02/24**: The admission at all stages of the examination is purely provisional, subject to his/her satisfying the prescribed eligibility conditions prescribed for the respective Department(s). If, upon verification, at any time before or after the examination, it is found that the candidate does not fulfill any of the eligibility conditions, his/her candidature for the examination will be summarily cancelled.

In view of the explicit provisions contained in Corrigendum dated 19/02/2024 and Clauses 6(ix) and 6(xv) of Advertisement No. 02/24, the allocation of departments is final and binding, being strictly based on merit-cum-preference exercised by the candidate during the e-dossier stage. Once a department is allocated, **no change of department is permissible** under any circumstances. Therefore, the applicant's request for change of department **cannot be acceded to** and is hereby **rejected**.

This issues with the approval of Competent Authority and in compliance of the directions of Hon'ble CAT.
