Subject- Notice for release of marks and calling of e-dossiers for the post of Lab Technician (Group-III) (Cardiology etc.), Lab Technician (Group-IV) (Biochemistry etc.) in H&FW, Lab Technician in NDMC & Laboratory Technician in Drugs Control Department under Post code 814/24.

1. The DSSSB vide its advertisement no. 06/2024 dated 05.03.2024 had advertised total 55 vacancies {38 vacancies (UR-13, OBC-11, SC-06, ST-04, EWS-04, Incl. PwBD – (Cat.(b)-02, Cat.(c)-02, Cat.(d & e)-01), Including Ex-SM-03, Including SP-01 in Health & Family Welfare}, {06 vacancies (UR-02, OBC-01, ST-03, Incl. PwBD (Cat. (b)-02, Cat.(d & e)-01) in Health & Family Welfare)}, {10 vacancies (EWS-02, OBC-05, SC-01, ST-02, Incl. PwBD (Cat.(b)-01 & Cat.(c)-01), Including Ex-SM-01)in NDMC} and {01 vacancies (UR-01 in Drugs Control Department)} for the Post of Lab Technician (Group-III) (Cardiology etc.), Lab Technician (Group-IV) (Biochemistry etc.), Lab Technician & Laboratory Technician in H&FW, NDMC & Drugs Control Department under Post code 814/24.
2. The written examination (online mode) Tier-I for recruitment in respect of this post was conducted on 22.06.2025.
3. The marks obtained by **1883 candidates** who appeared in written examination held on 22.06.2025 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
4. As per the Advertisement No. 06/2024 dated 05.03.2024, the mandatory minimum qualifying marks will be applicable only in r/o Section –B which is domain subject specific. There will not be any minimum qualifying marks in Section- A. However, combined aggregate marks of both Section-A & Section –B will be reckoned for preparing the final merit list. Accordingly, based on the performance in the examination, the candidates who have secured equal or more than the minimum marks for calling e-dossier as per details given below are being provisionally shortlisted and allowed to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.

5. As per advertisement “**Candidate must exercise at least one preference for a post. Candidates who do not submit their post preference(s) within the stipulated time, will not be considered for any post in the final result. Such Candidates shall not be provided with another opportunity to exercise preference for posts**”. Preferences once confirmed at the time of online calling of e-dossier will be treated as final and will not be allowed to be changed subsequently under any circumstances. **Therefore, candidates must be careful in exercising the preference.**”
6. Final selection and allocation of Department by DSSSB shall be based on Merit Cum Preference only. The User Department shall check the eligibility as per RRs and other terms and conditions of the advertisement notice.
7. Once a candidate has been allocated first available preference, as per merit, he/she will not be considered for subsequent preference(s). Subsequent request for change of Posts/ Departments by candidates will not be entertained under any circumstances. Candidates are, therefore, advised to exercise preference of Posts/ Departments very carefully. The option/ preference once exercised and confirmed by the candidates will be treated as FINAL and IRREVERSIBLE.
8. The final allotment of departments will be made on the basis of merit-cum-preferences of Departments of candidates. Once a post/department is allocated, no change of posts/Department will either be entertained or allowed by the Board.
9. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/ Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module.
10. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given above.
11. The e-dossier link shall be active from **10.02.2026 to 24.02.2026**. The candidate uploading e-dossier should ensure that he fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application.
12. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
13. Further, in case the candidates are unable to upload the documents within above stipulated time period due to any technical glitch in OARS module, they may report the same alongwith supporting evidence such as screenshots at e-mail of DSSSB helpdesk i.e. helpdesk-dsssb@delhi.gov.in. A window of next 48 hours (after expiry of e-dossier submission period) will be provided for reporting such technical glitches. In case where technical glitch is substantiated, an additional period of three days will be granted for uploading the documents in e-dossier system. However, this facility will be available only to those candidates who report the technical glitch within the specified timeline.
14. All the candidates who have been shortlisted for falling in consideration zone of selection **MUST** upload their all requisite/applicable documents in the said link in stipulated time.
15. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
16. The above short listing of candidates for calling of e-dossier for the postcode 814/24 will be subject to outcome of pending cases, if any.

17. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
