SUPPLEMENTARY RESULT NOTICE NO. 1597

**POST GRADUATE TEACHER (HISTORY) (MALE)
IN DIRECTORATE OF EDUCATION
UNDER POST CODE 138/12**

1. The DSSSB vide its vacancy notice/Advertisement No. 02/2012 with closing date 15/06/2012, had advertised 62 vacancies (UR-34, OBC-18, SC-10 incl. OH-01 and VH-01) for the post of Post Graduate Teacher (History) (Male) in Directorate of Education under Post Code 138/2012. The Board had conducted Tier I examination on 30/11/2014 and Tier II examination on 28/06/2015.
2. The results for the above post code were declared vide Result Notice No. 483 dated 15.03.2017, 517 dated 12.06.2017, 572 dated 15.11.2017 and 759 dated 25.01.2019.
3. The candidature of the 03 candidates under UR Category in post code 138/12 was cancelled vide Result Notice No. 759 dated 25.01.2019 as they failed to submit the requisite documents despite issuance of notices dated 05.07.2017 and 16.04.2018. These 03 unfilled UR vacancies under Post Code 138/12, which arose after the expiry of the waitlist panel, were returned to the User Department for inclusion in the next requisition.
4. The Ld. Tribunal vide order dated 20.08.2024 in OA No. 61/2019 in the matter of Sh. Yashpal Singh Ors. Vs. GNCTD & Ors. allowed the OA and directed DSSSB to rework the results for the post code 138/12 and declare the pending part of the result for the 3 vacancies. The Ld. Tribunal further directed that after declaration of result, the waitlist panel shall be operated.
5. The directions of Hon'ble CAT passed vide order dated 20.08.2024 in O.A. No. 61 of 2019 upheld by Hon'ble Delhi High Court vide Order dated 22.09.2025 in W.P.(C) No. 17084/2024.
6. The merit list for Post Code 138/12, up to the candidates under consideration, has been provisionally revised with the approval of the Competent Authority, in accordance with sub-clause (vii) of Clause 9, titled "Mode of Selection," of Advertisement No. 02/12. This provisional revision shall remain subject to the final comprehensive revision of the merit list for Post Code 138/12 by the Secret Cell, DSSSB.

7. As per the provisional revised merit, documents/dossiers were called from 06 shortlisted candidates (UR category) having Roll Nos. 26003944, 26000763, 26004315, 26000229, 26003916, and 26003727 vide Notice No. 1581 dated 13.01.2026. Out of these 06 candidates, those having Roll Nos. 26000763 and 26000229 failed to submit the required documents/dossiers. Accordingly, in terms of Clause 6 of Notice No. 1581 dated 13.01.2026, the candidature of candidates bearing Roll Nos. 26000763 and 26000229 is hereby rejected for Post Code 138/12.
8. In view of this, in compliance with the Order dated 20.08.2024 of Ld. Tribunal in O.A. No. 61/2019, upheld by Hon'ble Delhi High Court vide Order dated 22.09.2025 in W.P.(C) No. 17084/2024 and the Legal Opinion of Law Department, GNCTD, the following 03 candidates having following roll nos. are provisionally nominated under UR category for the post of PGT (History) (Male) under Post Code 138/12 in Directorate of Education, subject to fulfilling all other conditions of eligibility and also correctness of information furnished by the candidate in their application forms and dossiers. This provisional nomination shall remain subject to the final comprehensive revision of the merit list for Post Code 138/12 by the Secret Cell, DSSSB.

9. This result has been processed as per provisional merit in their respective category. **As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, no scrutiny of documents in the dossiers and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board.** The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement and relaxations as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 02/12 as on cutoff date 15/06/2012 before issuance of offer of appointment to the post.
10. The provisional nomination of the above 03 candidates **(UR-03)** candidates shall be further subject to thorough verification of candidature of the candidate by the User Department including the identity of the candidate.
11. The provisionally nomination of the above candidates shall further be subject to genuineness of the documents on the basis of which



they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the User Department in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

12. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
13. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate
14. The User Department shall also get the SC/ST/OBC/EWS/PwD certificates verified from the issuing authority before his /her appointment.



15. In case of EWS candidates, it may also be verified that the validity of EWS Certificate should be as per DoPT OM No. 36039/1/2019-ESTT(Res) dated 31/01/2019 and other instructions/guidelines issued from time to time by the competent authorities.
16. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about their eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
17. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
18. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
19. The Cut off marks scored by the last provisionally nominated candidate is as under:-

* The candidate having roll no. 26004315 having DOB 30/04/1981 being older in age than other candidates having equal marks has been last selected candidate in UR Category.

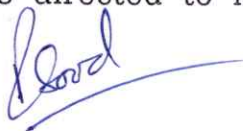

21. The Cut off marks scored by the last provisionally nominated waitlist candidate is as under:-

22. The User Department, being Cadre Controlling/Appointing Authority, shall strictly follow the merit based ranking of the candidate in the main list and the waiting list.
23. The User Department, at its own level, will utilize the Waiting List only after exhausting the main list and after affording sufficient opportunity to the provisionally nominated candidates as per the extant guidelines issued by the GNCTD/DoP&T.
24. The candidates in the Waiting Panel or the Balance Reserve Panel shall have no claim or right for appointment per se against the vacancies notified for the recruitment. They can only get the offer of appointment only in the event any vacancies (category-wise) arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc within one year of validity of panel.
25. While operating the waiting panel list, the User Department shall strictly follow instructions issued vide DoP&T OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98-Estt. (Res) dated 01/07/1998 and 43011/4/2018-Estt. (Res) dated 04/04/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category.
26. The User Department shall operate the waiting panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority as it shall render the excess appointment void and illegal *Ab initio*.
27. **The recruitment process for the Post of PGT (History)-Male under Post Code -138/12 in DoE has been closed. Further, the Waiting panel of the UR category candidate shall be valid up to 05/03/2027 i.e. one year from the date of declaration of this result.**
28. The waiting panel of UR category is valid for a period of 1 year from the date of declaration of this result for filling up the vacancies arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc within one year of validity of panel.
29. As soon as validity period of the waiting panel expires and /or number of notified vacancies are filled up hence waiting panel becomes redundant, the User Department shall return the cancelled and unutilized dossiers to DSSSB with complete details/statistics forthwith.
30. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
31. Wherever the Court has directed to not declare result without



leave of the court such cases will be dealt separately, if falling in main result/proposed 20% waiting panel list. The user department shall decide such cases subject to outcome of court case(s).

32. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
33. This provisional nomination shall remain subject to the final comprehensive revision of the merit list for Post Code 138/12 by the Secret Cell, DSSSB.
