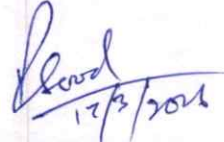
1. The DSSSB vide its advertisement No.07/2024 dated 12.03.2024 had advertised **Total-01 vacancy [UR-01]** for the post of **Book Binder** under Post Code- 73/24 in District & Session Courts.
2. The written examination (online mode) was conducted on **15.12.2025**. The marks obtained by **289 candidates** who have duly appeared in examination (online mode) held on **15.12.2025** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dssbonline.nic.in**
4. Based on the performance in the Objective Test (MCQ) examination (online Mode), a total of **10 candidates (UR-10)** who obtained marks above or equal to cut-off marks in UR, as detailed below, have been provisionally shortlisted to appear in Interview, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Interview separately.

Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Interview does not entitle them any right over the post.
6. As per the Examination Scheme, the Objective/(MCQ) test of 100 Marks exam has been taken for shortlisting candidates for Interview. The number of candidates to be called for Interview is ten(Maximum 10 times of the total vacancies). The minimum qualifying marks in Objective/(MCQ) is 50% i.e 50 for General Category and 45% i.e 45 for Reserved category.

7. **The details of Interview Exam shall be informed by the District & Session Court itself as per Advertisement.**
8. The above short-listing for Interview for the post of **Book Binder under POST CODE- 73/24 in District & Session Courts** will be subject to outcome of pending court cases, if any.
9. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.

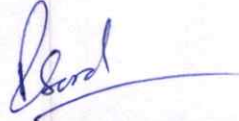
