Subject :- Releasing of Marks (Tier-I) and shortlisting of candidates for Tier-II Examination.

1. The DSSSB vide its advertisement No.06/23 dated 22.12.2023 read with corrigendum dated 29.11.2024 had advertised **total - 108 vacancies (UR-42, EWS-08, OBC-33, SC-17 & ST-08 Including PwBD -04)** for the post of **Section Officer (Horticulture) under Post Code- 803/23 in MCD & NDMC.**
2. The CBT examination (online mode) TIER-I was conducted on **16.04.2025, 17.04.2025, 21.04.2025 & 22.04.2025.**
3. The normalized marks obtained by **7520 candidates out of total 7522 appeared candidates** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssonline.nic.in**. Marks of remaining 02 candidates are not being disclosed as per the direction of Hon'ble High Court in WPC No 2301/2024.
4. Based on the performance in the Tier-I written examination (online Mode), a total of **1142 candidates who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II examination**, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

5. As per the examination scheme, for applicants of technical post code, the mandatory minimum qualifying marks will be applicable only in r/o Section-B which is domain subject specific. There will not be any minimum qualifying marks in Section-A. However, combined aggregate marks of both Section-A

- (100 marks) & Section-B (100 marks) will be reckoned for preparing the final merit list.
6. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, otherwise for selection in their respective category, subject to availability of vacancies,.
 7. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Tier-II Examination does not entitle them any right over the post.
 8. As per the Board Policy the minimum qualifying marks in one Tier written examination for UR & EWS Category Candidate is 40%, for OBC candidate is 35% and for SC, ST & PwBD candidate is 30%.
 9. **The details of Tier-II examination shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.**
 10. The above short-listing for Tier-II Exam for the post of Section Officer (Horticulture) under Post Code- 803/23 in Section Officer (Horticulture) will be subject to outcome of pending court cases WPC No.2301/2024 and other cases, if any.
 11. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
