Subject: Supplementary result in compliance of order dated 01.07.2025 passed by the Hon'ble High Court of Delhi in W.P.(C) No. 9617/2018 and connected matters titled Lokesh Kumar & Ors. vs. GNCTD & Ors. for the post of Fire Operator, Post Code 71/14, Delhi Fire Service.

1. This result is being issued in compliance of order dated 01.07.2025 passed by the Hon'ble High Court of Delhi in W.P.(C) No. 9617/2018 and connected matters titled *Lokesh Kumar & Ors. vs. GNCTD & Ors.* for the post of Fire Operator, Post Code 71/14, Delhi Fire Service.
2. **Brief facts:**
 - i. DSSSB, vide Advertisement No. 01/2014, advertised 803 vacancies (UR-290, OBC-126, SC-282, ST-105) for the post of Fire Operator in the Delhi Fire Service under Post Code 71/14, which were revised vide an Addendum dated 26.05.2015 from 803 to 841 (UR-321, OBC-126, SC-288, ST-106).
 - ii. The closing date/cut-off date for determining eligibility was 27.02.2014.
 - iii. The as per Advertisement scheme recruitment process comprised a Written Examination of 200 marks conducted on 31.08.2014, a Physical Endurance Test (PET) held in June 2016, and a Driving Skill Test conducted by the Delhi Fire Service in September 2017.
 - iv. The main result was declared vide Result Notice No. 606 dated 16.11.2017, followed by supplementary Result Notice No. 724 dated 10.10.2018, No. 763 dated 15.02.2019, No. 1054 dated 30.03.2020 & No. 1217 dated 02.12.2020.
 - v. The examination/selection process was conducted in accordance with the order of the Chief Fire Officer, Delhi Fire Services and the requisition and draft advertisement received. As per the prescribed scheme, the Physical Endurance Test (PET) carried 30 marks, which were proportionately scaled to 100 marks for preparation of the final merit list. The final merit was to be prepared out of 300 marks, comprising 100 marks each for the Physical Endurance Test, Driving Test and Written Test.
 - vi. Aggrieved candidates challenged the revised evaluation criteria before the Hon'ble CAT, which dismissed the OAs. The Hon'ble High Court, however, allowed the writ petitions and directed re-drawing of the merit list as stated :

"69. Keeping in view the above, we direct that the respondent no.3/DSSSB, in consultation with the respondent no.1/Government of NCT of Delhi and the respondent no.2/Delhi Fire Service Department, shall re-draw the result of the recruitment process strictly in accordance with the criteria laid down in Advertisement No. 01/14 dated 27.01.2014, that is, with a weightage of 200 marks for the Written Test and by treating the PET and the DST as only

qualifying in nature. For the PET, the minimum qualifying marks would be considered as 33% in the three tests as mentioned in the Office Order dated 01.06.2016. In case any of the petitioners is found to be eligible for appointment on the basis of this review merit list, they shall be appointed to the said post of Fire Operator with notional seniority to be placed below the already selected candidates.

70. Such selected petitioners would also be entitled to notional fixation of their pay; however, they will not be entitled to payment of actual pay or allowances till the date of their appointment. The entire exercise must be completed by the respondent no.3 within a period of eight weeks from today.

71. Taking into account that the selection process had culminated in the year 2017, we, however, restrict the relief only to the petitioners in the present set of petitions or any other petitions/OA challenging the impugned selection process that may be pending as on today.

72. With the above directions, the present petitions are disposed of. There shall be no order as to costs."

- vii. The Physical Endurance Test (PET) and Driving Skill Test (DST) are to be treated as qualifying in nature only, with the PET having a minimum qualifying standard of 33%. Eligible petitioners, if found within merit, shall be appointed with notional seniority and notional fixation of pay, without payment of arrears. The relief is confined to the petitioners and similarly placed candidates whose cases were pending as on the date of the judgment. The result of the recruitment process for the post of Fire Operator, Post Code 71/14, shall be re-drawn in consultation with GNCTD and the Delhi Fire Service, strictly in accordance with Advertisement No. 01/14 dated 27.01.2014.
- viii. The matter was also referred to the User Department, i.e., Delhi Fire Service. Delhi Fire Service also, which has concurred vide letter dated 24.11.2025, with the opinion of the Law Department also and has endorsed full implementation of the directions of the Hon'ble High Court.
- ix. In view of the judicial directions of the Hon'ble High Court, the legal opinion of the Department of Law, Justice & Legislative Affairs and the concurrence of the User Department, the current supplementary result nominating the eligible petitioner candidates is being declared.

3. Accordingly, **25 candidates (UR-15 & OBC-10)** were initially provisionally nominated under **Supplementary Result Notice No. 128 dated 29.01.2026**. On the basis of marks secured in the written examination, qualifying PET & Driving Skill Test (DST) and considering any relaxation claimed by the candidate in their application forms.

4. Further, **03 candidates (01 UR & 02 OBC)** claiming to be petitioners in W.P.(C) Nos. 13233/2018, 13234/2018 and 10914/2018 could not be considered at the time of issuance of Result Notice No. 128 dated 29.01.2026, as their names were not reflected in the list of petitioners available with the Board at that time. In addition, 01 UR candidate is being considered in compliance of the order dated 25.07.2025 passed by the Hon'ble Tribunal in O.A. No. 599/2018.



5. The nomination of the candidates is purely provisional and subject to satisfaction of the user department, criteria mentioned in the RRs & Advertisement and other relevant guidelines/circulars/OMs of the Government issued time to time.

Note: Roll No. 15007969 was earlier provisionally nominated vide Result Notice No. 724 dated 10.10.18. The candidate's dossier was returned by the User Department vide Letter No. 956 dated 17.06.2019 as the candidate did not submit acceptance of the offer of appointment despite three subsequent reminders; accordingly, his candidature for the said post was cancelled by the User Department. Therefore his candidature is not considered in current result.

7. List of petitioners in W.P.(C) No. 9617/2018 and connected matters who fall below the merit cut-off. These petitioners remain below the revised merit list and, therefore, cannot be nominated in the current result for their respective categories, following the re-drawn merit prepared in compliance with the Hon'ble High Court's order dated 01.07.2025

8. Candidates securing marks equal to the category-wise cut-off are considered separately as per the applicable tie-breaking provisions.

Note: - The above candidates secured marks equal to the category-wise cut-off. However, as per Note-08 of Advertisement No. 01/14, in case of a tie, the candidate older in age is placed higher in the merit list. Accordingly, after comparison of date of birth, the above candidates were placed lower in merit and therefore were not nominated.

9. The User Department shall ensure the compliance of the order of the Hon'ble Court and also ensure that the interests of the already nominated candidates of Post Code 71/14 are not adversely affected due to revision of result.

10. As per the Board (DSSSB) resolution dated 14.7.2022, DSSSB shall neither undertake scrutiny of documents uploaded by the shortlisted candidates in their e-dossier nor check the eligibility of the candidates as per the Recruitment Rules for the post or the terms and conditions stipulated in the Vacancy Notice relating to age, experience, educational qualification, reserved category status, PwBD status etc. These will be checked by the User Department at the time of Document verification for deciding the eligibility of the candidate for the post Code 71/14 as on cut-off date 27.02.2014, before issuance of offer of appointment to the candidate.

11. The provisional nomination of the above Total-04 (UR-02 & OBC-02) candidates on the basis of claims in their applications shall be subject to thorough verification of their candidature by the User Department including the identity of the candidate as per services department Circular No. F.16(3)/2007/S-III/1756-1763 dated 02/08/2021.

12. The provisional nomination of the above Total-04 (UR-02 & OBC-02) candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement and subject to thorough verification of their identity with reference to their photographs, signature/ handwriting etc. on the application form, admission certificate etc. by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate does not fulfill any of the eligibility conditions of the Recruitment Rules for the post or for any genuine reason. The decision of the User Department regarding the eligibility of the

candidate shall be final and binding on the candidate. The Competent Authority of the User Department concerned shall issue the offer of appointment to the candidate after being satisfied about his/her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential qualifications.

13. The User Department shall also check the eligibility of the reservation benefit claimed by the candidates, if any. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate, if applicable. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User Department is requested to ascertain the scrutiny/correctness of the same at its own level before issuing the offer of appointment to the provisionally selected candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at its own level.
14. In case of OBC, SC, ST Candidate, the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22/93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/ Circulars including order dated 07/03/2017 issued by Revenue Deptt., GNCTD after thorough verification of caste certificate.
15. User Department shall also get the SC/ST/OBC/EWS/PH (with sub category) certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017 and other instructions/ guidelines issued from time to time by the competent authorities.
16. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after verification of the correctness of the information furnished in



the application form/e-dossier and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard **vide MHA OM No. 2/29/54-RPS, 19/11/54 and other relevant guidelines/ OMs/Circulars issued by the competent authority.**

17. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

18. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User Department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respects for appointment to the post.

19. The User Department being Cadre Controlling/ Appointing Authority shall strictly follow the merit-based ranking of the candidates in the main list.

20. The User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98- Estt (Res) dated 01/07/1998 and 430111/4/2018-Estt (Res) dated 04/03/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category, if required.

21. The above result for the post of Fire Operator under Post Code 71/14 in Delhi Fire Service, GNCTD, shall be subject to the outcome of pending court cases, including WPCs/SLPs and any other cases, if any, pending before various courts/tribunals.

22. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
