



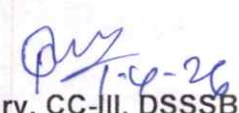

NOTICE

1. In compliance of the direction of the Hon'ble High Court in WP (c) No. 16257/2023 in the matter of GNCTD & Ors. Vs Sushma Rani, the E-dossier of the candidate having roll No. 111514300004 is called subject to attaining the minimum qualifying marks and correctness of the information furnished by the candidate in his application form for the post of TGT (Punjabi) Female, post code -143/17.
2. **The above court case linked candidate is here by informed to fill the E-dossier and upload all the documents of Education/Professional Certificate/Degree and Mark sheets/Caste Certificate/Disability certificate/proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module.**
3. The link for uploading of E-dossier shall be kept open for a period of 15 days w.e.f. **08/04/2026 to 22/04/2026** only for the above court case linked candidate, failing which his candidature will be rejected and no further opportunity will be given on whatsoever ground.
4. The candidate uploading E-dossier should ensure that he fulfils all the eligibility criteria as on the cutoff date i.e. 31.01.2018. The Shortlisted candidate is also being separately informed through SMS & E-mail on his registered mobile number & E-mail id as additional facility. **If, any candidate fails to upload the E-dossier during the above said period, his candidature will be rejected and no further opportunity for uploading E-dossier will be given on whatsoever ground.**
5. **THE LINK FOR UPLOADING OF E-DOSSIER SHALL BE OPENED ONLY FOR THE ABOVE COURT CASE LINKED CANDIDATES W.E.F. 08/04/2026 TO 22/04/2026.**
6. Mere asking the candidate for uploading documents in the e-dossier module does not confer his any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfils all the required eligibility conditions. It is reiterated that if the candidate fails to upload his documents on or before the date as mentioned above he will not be given any further opportunity and his candidature will be treated as cancelled.
7. This issues with the approval of Chairman, DSSSB.

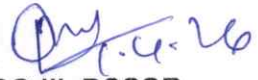
