Sub: Releasing of TIER-II marks and calling of e-dossiers for the post of Manager in DSIIDC under Post Code 107/23.

1. The DSSSB vide its advertisement No. 03/23 had advertised read with corrigendum dated 04.03.2024, 27.05.2024 & 04.10.2024 had advertised **Total- 20 vacancies(including PwBD Cat (a) 01) [UR- 10, EWS- 02, OBC- 05, SC- 02 & ST- 01]** for the Post of **Manager under Post Code- 107/23 in DSIIDC**.
2. The Online examination for Tier-II was conducted on 30.10.2025 and a total of **259 candidates** appeared. The marks statements of the above post code have been uploaded on the Board's website. Candidates can view their marks by logging on to their account in OARS module on www.dsssonline.nic.in
3. Based on the performance in the Online examination for Tier-II, a total of **61 candidates** who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, **have been provisionally shortlisted to upload their requisite documents in e-dossier through the OARS module**. All the 61 shortlisted candidates for the above mentioned post code are hereby directed to login to the e-dossier module and upload all the documents of education certificates/mark sheets/caste certificate/Admit cards/proof of Govt. servant/Ex Serviceman/PH Certificate/EWS Certificate etc., as applicable, in the e-dossier module in OARS link in their individual accounts in OARS module.

Note : In case of candidate securing equal marks within the same category the candidate senior in age has been placed higher in merit. Accordingly, such candidate has been shortlisted for calling of e-dossier purpose as per the provision of advertisement.

4. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for uploading of e-dossier does not entitle them any right over the post.
5. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.

6. As per the Advertisement the minimum qualifying marks in examination for different categories as under:-

UR & EWS : 40%
OBC (Delhi) : 35%
SC, ST & PwBD : 30%

Ex-servicemen will be given 5% relaxation in their respective categories subject to a minimum of 30%

7. Kindly note that the e-dossier link will be activated in r/o only those candidates who are provisionally shortlisted to upload e-dossier as per details given in Para 03 above.
8. All the candidates who have been shortlisted for uploading e-dossier **MUST** upload their all requisite/applicable documents in the said link within the stipulated time period.
9. The e-dossier link shall be active from **24.04.2026 to 08.05.2026** The candidate uploading e-dossier should ensure that he/she fulfils all the eligibility criteria/all essential qualifications as per RRs for the said post as on closing date of application i.e. 20.12.2023.
10. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail id as an additional facility. If any candidate fails to upload the e-dossier during the above period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
11. Further, in case the candidates are unable to upload the documents within above stipulated time period due to any technical glitch in OARS module, they may report the same alongwith supporting evidence such as screenshots to e-mail of DSSSB helpdesk i.e. helpdesk-dsssb@delhi.gov.in within next 48 hours (after expiry of e dossier submission period). The technical glitch shall be substantiated/ verified and only then, an additional period of three days will be granted for uploading the documents in e-dossier system.
12. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfils all the requisite eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he will not be given any further opportunity and his/her candidature will be treated as cancelled.
13. While every care has been taken in preparing the above shortlisting, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
