2. The online One Tier (General) written examination for recruitment in respect of this post was conducted on 05/10/2025.
3. The Prorated marks obtained by 301 candidates who appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging in to their account in OARS module on www.dsssonline.nic.in.
4. Based on the performance in the Tier-I examination, the candidates who have secured equal or more marks in their respective category as per details given below in the table have been provisionally shortlisted for Skill Test subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.

5. As per the Examination Scheme, short listing is being made on the basis of marks obtained in online Tier-I examination (Objective-MCQ) for 200 marks. The shortlisted candidates shall be called for Skill Test separately.

Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Skill Test does not entitle them any right over the post.
7. The above shortlisted candidates for Skill Test for the post code mentioned above will be subject to outcome of pending court cases, if any.
8. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
