1. The DSSSB vide its advertisement No.05/24 had advertised **Total- 04 vacancies** (UR-03, OBC-1) for the Post of **B.C.G. Technician in Municipal Corporation of Delhi (MCD)**, under **Post code 31/24** and conducted one tier (Technical) examination (online mode) for recruitment on 07<sup>th</sup> May 2025.
2. The marks statement of **03 candidate** who appeared in online examination (One Tier-Technical) held on 07<sup>th</sup> May 2025 have been uploaded on Board's website. Candidate can view their marks by logging into their account in OARS module on [www.dsssonline.nic.in](http://www.dsssonline.nic.in).
3. As per the Advertisement No. 05/24 dated 05.03.2024 para 5(v) the minimum qualifying marks (wherever applicable) for different categories (UR/SC/ST/OBC/EWS/PwBD/Ex-SM) are as under:

General/EWS	:	40%
OBC(Delhi)	:	35%
SC/ST/PH(PwBD)	:	30%

Ex-Servicemen will be given 5% relaxation in their respective categories subject to a minimum of 30%, if post is reserved for Ex-Servicemen.
4. As per the Advertisement No. 05/24 dated 05.03.2024, the mandatory minimum qualifying marks in Tier-I Examinations will be applicable only in r/o Section-B which is domain subject specific. There will not be any minimum qualifying marks in Section-A. However, combined aggregate marks of both Section A & Section-B will be reckoned for preparing the final merit list.
5. Based on the performance in online examination **None candidate** found qualified in UR and OBC category. Hence, **NIL Candidate is shortlisted** for uploading of e-dossier for the post of B.C.G. Technician in Municipal Corporation of Delhi (MCD), for Post Code – 31/24.
6. The above result for the post of Post code 31/24, B.C.G. Technician in Municipal Corporation of Delhi (MCD), is subject to outcome pending courts cases related to this post, if any, in various courts.
