ORDER

- This order shall dispose of the representation dated 20.04.2021 filed by Ms. Monika Tomer (Roll No. 11140903680), a candidate for the post of Nursing Officer, Post Code-03/18 in Health and Family Welfare Department in compliance of the directions of Hon'ble Central Administrative Tribunal order dated 22/06/2021 in OA No.1130/2021 and M.A. 1391/2021, in the matter of Ms. Monika Tomer V/s Govt. of NCT of Delhi and Ors.
- 2. The Hon'ble Tribunal while disposing the Original Application No.233/2021 has given the following direction:
 - "4. In view of the aforesaid without going into the merit of the applicant's claim, the present OA is disposed of with direction to the respondents to consider the applicant's aforesaid representation 20.04.2021 and to dispose of the same by passing a reasoned and speaking order as expeditiously as possible and in any case within eight weeks of the date of receipt of a copy of this order.
 - 5. OA is disposed of in the aforesaid terms. No Costs."
- 3. That Ms. Monika Tomer, the applicant vide her representation dated 20/04/2021 (Annexed in the O.A. as Annexure A-3, however, in the Order dated 22/06/2021, it has been referred as Annexure A-1) has prayed to select all shortlisted candidates on the post of Nursing Officer who could not be selected in final list so that they could provide their services to Delhi. Applicant has further requested to select all the candidates who were shortlisted and uploaded their e-dossiers.
- 4. That as per advertisement No. 02/2018, the total vacancies in Post Code 03/18 was advertised as 684 (UR-345, OBC-185, SC-103, ST-51including EXSM-68, OH (OL)-27. Later on vacancies in the above mentioned post code has been revised, which is mentioned below, vide Addendum to advertisement no. 02/2018 dated 26.08.2019. The revised vacancies were as 1024 (UR-516, OBC-277, SC-154, ST-77 including EXSM-102, OH (OL)-41.

- It is pertinent to mention here that vide Order No. DH&FW-0014/100/2016-HR Nursing-Secy. (H & FW)/285-296 dated 08 Nov, 2016 it has been 5. informed by the user department that the nomenclature of Staff Nurse has been changed to Nursing Officer.
- The prescribed cut-off date for determining educational qualification, age, experience and other eligibility conditions against the post shall be 6. determined as on the closing date of online submission of application i.e. 13/08/2018.
- Mode of selection to the post code 3/18 was stated as Tier I (Technical) (1-T-T) examination: - Tier I Examination for 200 marks, in the advertisement No. 7. 02/2018.

- 10. Result for the Post Code was declared vide Result Notice No. 996 dated 13.6.2020 and subsequent Supplementary Result Notice Nos. 1058 dated 30.09.2020, 1086 dated 2020, 1123 dated 30.03.2021 and 1131, 08.05.21. Last Selected OBC category candidate obtained 95.68 marks. The Waitlist Panel has already been expired on 12.06.2021.
- 11. Applicant could not be selected as she obtained less marks than the last selected candidate and being below in merit.
- 12. It is stated that DSSSB being the recruiting agency of GNCT of Delhi is mandated to process the selection for various group C and B (non-gazetted) posts as per the requisition of the user departments. It processes the selection and nominates candidates after, prima facie, determining eligibility based on documents/ information submitted by the candidates in their application forms. In the Post Code User Department had given requisition for 1024 (UR-516, OBC-277, SC-154, ST-77 including EXSM-102, OH (OL)-41. Result process for the Post Code has been closed vide Result Notice No. 996 dated 13/06/2020.
- 13. The candidates in the waiting panel or the balance reserve panel will have no claim or right for appointment per se against the vacancies notified for the recruitment. They can get the appointment only in the event any vacancy arises as a result of selected candidates from the main result list not joining the employment for the reasons as stated above within one year of validity of waiting panel. Such vacancies shall be filled up strictly according to the merit based rankings in the waiting panel. Further, no candidates from the waiting panel will be considered against any future/other vacancies.
- 14. The appointments from the waiting panel and the reserve panel is restricted to the extent of the vacancies advertised by DSSSB. The validity of the waiting panel and the reserve panel shall deemed to expire as soon as the number of vacancies advertised are filled up or after one year from the date of declaration of the main result, whichever is earlier. Any vacancy arising, thereafter, due to any reasons shall not be filled out of the relevant waiting list.
- 15. The result process of the post code has already been closed vide Result Notice No. 996 dated 13/06/2020 and the waiting panel has also expired on 12.06.2021.
- 16. In view of the fact that the role of DSSSB is limited to make recommendation only to the extent of vacancies advertised and not beyond it, the prayer made by the applicant in her representation dated 20/04/2021 is unacceptable that

all the candidates who were shortlisted for uploading of e-dossiers in the Post Code 03/18, may be selected.

- 17. This issues with the approval of Competent Authority and in compliance of the directions of Hon'ble CAT.
