RADIO TELEPHONE OPERATOR, POST CODE-72/14 IN DELHI FIRE SERVICE.

In continuation of Rejection Notice No. 664 dated 07.09.2020, Rejection Notice No. 716 dated 19.11.2020, Rejection Notice No. 741 dated 31.12.2020 & Rejection Notice No. 748 dated 02.02.2021, on scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of **Radio Telephone Operator, Post Code-72/14 in Delhi Fire Service** and the terms and conditions of the advertisement, the candidature of 01 candidate in respect of the above said post code is rejected for the reason/ remarks mentioned against their roll number:-

1	11240700115	As per RRs, three years diploma in Electronics/ Wireless Telecommunications Engineering OR B.Sc. with Physics and Maths as one of the subject, Or Passed Grade-II (Wireless Operator Examination) from Ministry of Home Affairs, Govt. Of India Or equivalent, Or 10+2/ Intermediate Science Or equivalent from a recognized University/Board with 3 years Radio Wireless Operators in Govt. Organization was required in the e-dossier. But the candidate had uploaded only 10 th certificate. Accordingly, he was given 1 st opportunity w.e.f. 26.07.2021 to 04.08.2021 to upload the deficient/requisite documents in the e-dossier. But he had uploaded 1 st page of admit card in the e-dossier. Therefore, he was given 2 nd and final opportunity w.e.f. 05.08.2021 to 09.08.2021 to upload the deficient /requisite documents in the e-dossier. The candidate in 2 nd opportunity has uploaded 12 th certificate and failed to upload the certificate of 03 years Radio Wireless Operators which is essential qualification with Intermediate as per RRs. As, the candidates failed to upload the deficient /requisite documents in the e-dossier even after giving two more opportunities, his candidature is rejected for not having requisite qualification as per RRs.
