ORDER

This order shall dispose of the representation of Sh. Sumit Pathak dated 23/11/2021, in compliance of the direction of Ld. CAT order dated 15/2/2023 in OA No. 2842/2021 in the matter of Sumit Pathak vs GNCTD.

The Ld. CAT while disposing of the original application No. 2842/2021 vide judgment dated 15/2/2023 has directed that "the OA is disposed of with a direction to respondent no.2 to consider the applicant's pending representation dated 23/11/2021 by passing a reasoned and speaking order."

A representation/mercy appeal dated 23/11/2021 was submitted by Sh. Sumit Pathak, (a candidate/applicant for the post of PGT (English) Post Code - 25/20 in UR category vide Roll No. 121102500213) wherein he stated that he failed to upload the document within stipulated time period of 8/10/2021 to 22/10/2021 due to serious medical illness. He pleaded to give him another chance to upload his E-dossier being last attempt, unemployed and having better marks than cut off and enclosed the cut off list, marks obtained in PGT exam and medical treatment certificate.

In pursuance of aforesaid Hon'ble Court Order while considering the representation it has been found that applicant has unequivocally stated that for certain reason he could not be able to upload the documents. The applicant did made a representation on 23/11/2021 after lapse of stipulated period for uploading E-dossier which was 8/10/2021 to 22/10/2021 and stating personal reasons such as illness, being an unemployed person and is his last attempt which is not rational to consider the case on individual, personal basis.

There is no such policy to allow or accept E-dossier in any situation physically or granting extension after lapse of stipulated time and on consideration of personal illness, last attempt, being unemployed etc.

Further, as enlightened in Pushpender Singh Parnami (Supra) wherein Hon'ble High Court has stated that :

"The submission of the petitioner is that he belongs to a very remote area in the State of Rajasthan and due to lack of internet connectivity and his illness he could not learn about the result declared by the DSSSB on its website. We are unable to accept this submission. The petitioner while applying for the post of PGT (History) was well aware that the result of the written examination would be uploaded by the DSSSB on its website and it was for the petitioner to

track the same and to respond in terms of the advertisement issued by the respondent.

Having missed the bus, he cannot be permitted to submit his documents/e-dossiers after the cut-off date. If such relaxation were to be granted to one candidate, it would be discriminatory in respect of others, who may have similarly missed the bus and this would render the entire process undertaken by the DSSSB as open ended.

In view of the aforesaid, we find no merit in the present petition and the same is dismissed."

Similarly, in another case titled Ms. Jyoti vs GNCTD vide WP (C) No. 4085/2019 and as far as stating or giving reason i.e., securing better marks than cut off as stated in representation and unable to upload E-dossier, if such applicant is permitted a chance to upload the E-dossier it would amount to discrimination against others who may have similarly being not able to upload their E-dossiers during the stipulated date and time.

Whereas the applicant herein failed to upload his document in OARS portal in time therefore the Rejection Notice No. 860 dated 11/5/2022 is totally justified and legal.

Therefore in pursuance of above stated Ld. CAT order dated 15/2/2023, the representation dated 23.11.2021 is considered in detail and being devoid of merit , not tenable, hence the same is rejected.

This issues with the approval of Chairman, DSSSB.
