## SUPPLEMENTARY RESULT NOTICE NO: 750 DATED 24.02.2021

### PHYSICAL EDUCATION TEACHER, POST CODE-210/14 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 02/2014 dated 12/12/2014 had advertised total **424** [UR-208, OBC-127, SC-52, ST-37] vacancies for the post of **Physical Education Teacher, Post Code-210/14 in Directorate of Education** with closing date as 25.01.2015. Tier-I examination in offline written examination mode was conducted on **30/04/2017**.

2. On the basis of offline written examination of Tier-1 held on **30/04/2017** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.02/2014 and RRs for the post of **Physical Education Teacher, Post Code-210/14** in Directorate of Education, a total of **316** (UR-196, OBC-72, SC-45, ST-03) candidates were provisionally nominated for the post of **Physical Education Teacher, Post Code-210/14** vide Result Notice No. **202** dated **07.11.2017**. Subsequently, **11 candidates** (UR-06, OBC-01, SC-04), **08 candidates** (UR-05, OBC-01, SC-02) were nominated vide result Notice No. **221** dated **28.12.2017**, **235** dated **22.03.2018** respectively. Further, 01 candidate under UR category was provisionally nominated in compliance of the direction of the Hon'ble CAT in O.A. No. 4000/2017 in the matter of Amit Yadav Vs. GNCTD vide Supplementary Result Notice no. **564** dated **17.12.2019**. Thereafter, in Compliance of the directions of the Hon'ble CAT in O.A. No. 4242/2017, OA No. 4115/2017, OA No. 4519/2017 and OA No. 1664/2018, **14 candidates** (UR-11, OBC-02, SC-01) were nominated vide **Supplementary Result Notice no. 666** dated **08.09.2020**.

3. Furthermore, in compliance of the direction of the Hon'ble CAT in O.A. No. 944/2018, one candidate whose candidature was rejected earlier vide Rejection Notice No. 203 dated 07.11.2017 was re-examined in accordance with DoPT O.M. dated 03.10.2013 and accordingly, his candidature is revived for the post of Physical Education Teacher, Post Code-210/14.

4. Therefore, in continuation to Result Notice No. **202** dated **07.11.2017**, result Notice No. **221** dated **28.12.2017**, Result Notice no. **235** dated **22.03.2018**, Supplementary Result Notice no. **564** dated **17.12.2019**, Supplementary Result Notice No. 666 dated 08.09.2020 and in compliance of the directions of the Hon'ble CAT in O.A. No. 944/2018, the following **01 candidate under UR category** as detailed below

is also provisionally nominated against his/her roll number by giving age relaxation under sportsperson category on the basis of offline written examination of Tier-1 held on **30/04/2017** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.02/2014 and RRs for the post of **Physical Education Teacher, Post Code-210/14** in Directorate of Education.

5. The Hon'ble CAT vide order dated 09.12.2020 in O.A. No. 944/2018 has passed the directions that **"The question as to whether the 'cross country' event is part of Athletics, from the point of respondents, needs to be examined. If there is any doubt in this behalf, the respondents can also consult the competent authority in this behalf. In case the event of 'cross country' is treated as a part of Athletics, the applicant shall be entitled to the benefit of age relaxation of five years. If any different action is taken in this behalf, the same shall be communicated to the applicant within a period of two weeks"**. Therefore, the User Department i.e. Directorate of Education is requested to thoroughly examine the sports field & sportsperson certificate provided by the above candidate in the light of directions passed by the Hon'ble CAT in O.A. No. 944/2018 & Para-A (IV), (V) & Para-H of DoPT O.M. F. No. 14034/01/2013-Estt. (D) Dated 3<sup>rd</sup> October, 2013 regarding consolidated instructions on incentives for sportsperson in Government of India and if required, also take clarification from the Competent Authority regarding cross country being part of athletics as directed by the Hon'ble Tribunal vide order dated 09.12.2020 in O.A. No. 944/2018 before issuance of any appointment letter. If the candidate does not fulfill the eligibility criteria with regard to sportsperson category, his e-dossier may be returned after cancellation of his candidature at your level.

6. The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to his photographs, signatures/handwriting etc. on the application form, admission certificate etc. **The candidature of the above candidate are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent**



Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.



11. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

12. The result process for the above post code stands closed in all respect.

13. Waiting panel for post code-210/14 has already been expired on 06.11.2018 as per result notice no. 202 dated 07.11.2017.

14. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

15. The category wise marks obtained by the last selected candidates have been given as under:-
