MOTOR VEHICLE INSPECTOR (MALE) IN TRANSPORT DEPARTMENT UNDER POST CODE 21/2012 AND 42/2013

The Board had conducted the Tier I examination for post codes 21/2012 and 42/2013 on 28/12/2014 and the Tier II examination on 29/03/2015. Thereafter, the final result was declare vide Result Notice No. 330 dated 24.07.2015 and Result Notice No. 341 dated 13.10.2015 and subsequent corrigendum dated 16.10.2015 and 20.10.2015 and had nominated 09 candidates (05 candidates under postcode 21/2012 and 04 candidates under post code 42/2013) for the post of Motor Vehicle Inspector (Male) in Transport Department in the pay scale of Rs. 9300-34800 having Grade Pay of 4200/-(Non-Gazetted-Non Ministerial).

The candidature of Viplove Singh having Roll No. 59000388 was kept pending in Result No. 330 dated 24.07.2015 on account of Court Case filed by the candidate in OA No. 4688/2014. Now, in compliance of Ld CAT order dated 05.10.2016 in MA No. 100/1855/2016 in RA No. 167/2015 in OA No. 100/4688/2014 in the matter of Viplove Singh Vs The Chairman, DSSSB & Ors, the candidature of Sh Viplove Singh is being considered for the postcode 21/2012, in view of the confirmation of the fact that the candidate had submitted manual application form, in offline mode, for the post code 21/2012 and was allotted ID No. 2688634.

The candidature of Sultan Ali having Roll No. 59000384 was kept pending in Result No. 330 dated 24.07.2015 on account of a Court Case filed by the candidate in OA No. 4665/2014. In compliance of Ld CAT order dated 16.12.2015 in OA No. 4665/2014 in the matter of Sangeeta Deepak & Ors vs GNCTD, wherein Sultan Ali was applicant No. 12, the candidature of Sh Sultan Ali is now being considered for the postcode 21/2012 in view of the confirmation of the fact that the candidate had submitted manual application form, in offline mode, for the post code 21/2012 and was allotted ID No.2574811. His candidature is still being kept pending for want of experience



certificate, as on scrutiny of his dossier it has been found that the candidate had furnished only offer of appointment instead of experience certificate.

The candidature of Vikas Chaudhary having Roll No. 59000385 was kept pending in Result No. 330 dated 24.07.2015 on account of a Court Case filed by the candidate in OA No. 4557/2014. In compliance of Hon'ble High Court order dated 27.11.2015 in WPC 9869/2015, CM No 23868/2015 in the matter of Vikas Chaudhary vs GNCTD, the candidature of Sh Vikas Chaudhary has now been considered for the postcode 21/2012 in view of the confirmation of the fact that the candidate had submitted manual application form, in offline mode, for the post code 21/2012 and was allotted ID No. 2291150. The candidature of the candidate is still being kept pending in OBC Category in post code 21/2012 as the candidate has furnished the OBC certificate after the cut-off date, till the decision of the Hon'ble Supreme Court as the review petition filed before the Hon'ble Supreme Court in the matter of Ram Kumar Gijroya vs DSSSB vide CA No. 1691 of 2016 arising out of SLP (C) No. 27550 of 2012 is decided.

In compliance of Ld CAT order dated 22.01.16 in OA No. 1173/2015, MA No. 4403/2015 in the matter of Vikram Singh vs GNCTD, the candidature of Sh Vikram Singh has now been considered for the postcode 21/2012 in view of the confirmation of the fact that the candidate had submitted manual application form, in offline mode, for the post code 21/2012 and was allotted ID No. 2118033. The candidature of Vikram Singh having Roll No. 59000250 is being kept pending for want of necessary documents viz. educational qualifications/driving license/experience certificate, to enable the Board to scrutinize his eligibility for the post.

On the basis of the merit list of Tier- II examination and after determining eligibility for the post as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidates, whose candidature was kept pending in Result No 330 dated 24.07.2015, are hereby provisionally selected to the post of Motor Vehicle Inspector (Male) in Transport Department under post code 21/2012.

The candidature of the candidates having Roll number -59000017 in post code 21/2012 and 59000062, 59000114 and 59000231 in post code 42/2013 are rejected as they have not been found eligible as per the RRs of the post.

The candidature of the candidates having Roll number 59000376, 59000367 in post code 21/2012 and 59000056 in post code 42/2013 has been kept pending, for seeking clarification from the User Department regarding eligibility of their respective experience certificate.

Further, candidature of candidate having roll number 59000009 has been kept pending in post code 42/2013 due to a court case filed by the said candidate in WPC 2973/12, which is pending before the Hon'ble High Court.

The selection of the above 02 Candidates shall be further subject to the thorough verification of the candidature of the candidates by the User Department including the identity of the candidates. The candidature of a candidate is liable to be cancelled by the User Department, in case a candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the DSSSB and the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any, as per the reservation policy of the Government of NCT of Delhi. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application form vis-à-vis the original documents including the experience certificate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post, unless the appointing authority is satisfied after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.

The above selection is subject to the outcome of the Court case in TA 58/13 in WPC 2973/2012 in the matter of Rahul Sharma Vs UOI & ors, TA 58/13 in WPC 2973/2012 in the matter of Sumit Pawar Vs UOI & ors and OA no 2200/15 in the matter of Naveen Verma Vs GNCTD.
