PATWARI (MALE) IN REVENUE DEPARTMENT, GNCTD

UNDER POST CODE- 13/17

Attention is drawn to the Notice No. 830 dated 01.10.2019 vide which the marks of 9395 candidates were declared who appeared for the online examination held on 16.06.2019 and 18.06.2019 for the post of Patwari (Male) in Revenue Department, GNCTD , Post Code- 13/17. Attention is also drawn to the Result Notice No. 968 dated 31.12.2019 and 1102 dated 29.06.2020, vide which results were declared for the post of Patwari (Male) in Revenue Department, GNCTD , Post Code- 13/17.

2. However, subsequently, on analysis of Second page of Admit Cards of the Examination while forwarding of e-dossier to the User Department, it has been found that Sh. Atul Kumar whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the above said post code Exam:-

3. Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:-

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/ herself liable to criminal prosecution, be liable:

(a) To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or

(b) To be debarred either permanently or for a specified period from any examination held or selection made by them and or,

(c) To take disciplinary action if he/ she is already in service under Government and or,

(d) To take any other legal action"

4. Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post Codes in online, offline & PET examination:-

"If any case of impersonation comes to notice then Overall In-charge & Observer shall lodge FIR against both persons i.e. candidates who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/ Commissions."

5. Thus, it is clear that the candidate had arranged to have another person taking examination in place of him. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

i) Appearing for examination for another candidate or arranging to have another

person taken an examination for the candidate.

- ii) Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii) Helping or receiving help from other candidates to impersonate.
- iv) Signing/ getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v) Providing admit card to another person to enable him to appear on behalf of the candidate.

6. Further, the candidate has also indulged in the act of **FORGERY** by altering the identity proof of candidate, admit card etc, and produced these documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.

7. Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.

8. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the candidate.

9. The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view of the above facts and circumstances, **the candidature of Sh. Atul Kumar S/o Dharampal R/O Gali No. 6 Gautam Colony JK FARM Road Narela, Delhi, having Date of Birth : 26.06.1997 bearing Roll No. : 11310100912 of Post Code 13/17 is hereby cancelled and the provisional selection made vide Result Notice No. 968 dated 31.12.2019 of Sh. Atul Kumar S/o Dharampal R/O Gali No. 6 Gautam Colony JK FARM Road Narela, Delhi, having Date of Birth : 26.06.1997 bearing Roll No. : 11310100912 of Post Code 13/17, is hereby rescinded.**
