**SHORTLISTING OF CANDIDATES FOR APPEARING IN
PHYSICAL ENDURANCE TEST-III (PET-III)
FOR THE POST OF ASSISTANT SUPERINTENDENT
IN DELHI PRISONS DEPARTEMENT (POST CODE-38/13)**

The DSSSB vide its advertisement No. 02/2013 with closing date 02.08.2013, had advertised 35 vacancies (UR-19, OBC-09, SC-05, ST-02; out of which 04 vacancies were reserved for EXSM) for the post of Assistant Superintendent in Delhi Prisons Department in the pay scale of Rs. 5200-20200 having Grade pay of 2800/- (Group-C Jail cadre). The Board had conducted the written examination on 09.03.2014 for the post of Assistant Superintendent under postcode 38/13. On the basis of the written examination the candidates were shortlisted to appear for PET, which was qualifying in nature. After conducting the Physical Endurance test (PET-I & PET-II) in respect of shortlisted candidates from 16.03.2015 to 22.03.2015 and also from 12.07.2016 to 13.07.2016. 27 candidates who qualified the PET were nominated to the post of Assistant Superintendent under post code 38/13 vide result notice No. 342 dated 15.10.2015 and subsequent result notice No. 350 dated 18.12.2015, result notice No. 367 dated 14.01.2016, result notice No. 415 dated 28.07.2016 and result notice No. 511 dated 16.05.2017.

As on date, 12 (UR-02, OBC-03, SC-05 & ST-02 including 01 EXSM) vacancies are left unfilled, including vacancies arise due to cancellation of candidature of 04 candidates by user department.

In respect to the remaining 12 vacancies in view of the request of the user department vide letter No. F.18(314)/Estt./PHQ/CJ/2012/CD-8389/3112-14 dated 14.06.2017, **131** candidates as per details below are hereby provisionally shortlisted for appearing in the PET-III in the ratio of 1:10 of available vacancies, subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their respective online application form.

The shortlisted candidates shall be called for PET-III separately; all the candidates can view their status by logging into their account in OARs module on www.dsssb.online.nic.in

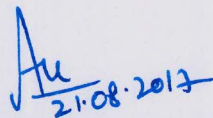
The above 131 candidates have been shortlisted for appearing in PET-III on the basis of details provided by them in their on line application form OARs. Since document have not been called from the candidates along with application, as such detailed scrutiny regarding their eligibility and admissibility of reservation benefit have not been carried out and therefore mere inclusion of the candidate in the list for qualifying candidates for appearing in PET-III does not entitle his right over the post. In case of OBC candidates, the details as to whether they belong to OBC (Delhi) or not, as declared by them in their OMR on the day of exam have been considered for eligibility of reservation benefit, subject to verification of their claim.

No candidates who remained absent during PET conducted earlier shall not be included in the PET-III.

Final selection against unfilled vacancies shall be made in accordance with merit list drawn as per result of written examination subject to availability of vacancies and the candidates qualifying the PET-III and also fulfilling of all conditions of eligibility as prescribed by the RRs, admissibility of reservation benefits and terms and conditions advertised.

While every care has been taken in shortlisting the candidates for appearing in PET-III, DSSSB reserves the right to rectify errors and omissions if any detected at any stage.

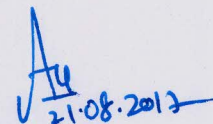
