SHORTLISTING OF CANDIDATES FOR APPEARING IN
PHYSICAL ENDURANCE TEST-III (PET-III)
FOR THE POST OF MATRON
IN DELHI PRISONS DEPARTEMENT (POST CODE-36/13)

The DSSSB vide its advertisement No. 02/2013 with closing date 02.08.2013, had advertised 81 vacancies (UR-41, OBC-22, SC-12, ST-06 out of which 08 vacancies were reserved for EXSM) for the post of Matron in Delhi Prisons Department in the pay scale of Rs. 5200-20200 having Grade pay of 1900/- (Group-C Jail cadre). The Board had conducted the written examination on 02.03.2014 for the post of Matron (Female) under postcode 36/13. After conducting the Physical Endurance test (PET-II) in respect of shortlisted candidates on 14.07.2016 candidates were nominated to the post of Matron (Female) under post code 36/13 vide result notice No. 417 dated 29.07.2016

As on date 30 (UR-08, OBC-10, SC-11 & ST-01 including 08 EXSM) vacancies are left unfilled. As per the merit list no EXSM candidate is available for selection to the post. Therefore as per the DOPT OM dated 12.03.1987 read with 20.03.1987, 8 vacancies of Exsm shall be carried forward to next recruitment.

In respect to the remaining 22 vacancies in view of the request of the user department vide letter No. F.18(314)/Estt./PHQ/CJ/2012/CD-8389/3112-14 dated 14.06.2017, 49 candidates as per details below are hereby provisionally shortlisted for appearing in the PET-III in the ratio of 1:10 of available vacancies, subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their respective online application form.

The shortlisted candidates shall be called for PET-III separately, all the candidates can view their status by logging into their account in OARs module on www.dsssb online.nic.in

The above 49 candidates have been shortlisted for appearing in PET-III on the basis of details provided by them in their on line application form OARs. Since document have not been called from the candidates along with application, as such detailed scrutiny regarding their eligibility and admissibility of reservation benefit have not been carried out and therefore mere inclusion of the candidate in the list for qualifying candidates for appearing in PET-III does not entitle his right over the post.

No candidates who remained absent during PET conducted earlier shall not be included in the PET-III.

Final selection against unfilled vacancies shall be made in accordance with merit list drawn as per result of written examination subject to availability of vacancies and the candidates qualifying the PET-III and also fulfilling of all conditions of eligibility as prescribed by the RRs, admissibility of reservation benefits and terms and conditions advertised.

While every care has been taken in shortlisting the candidates for appearing in PET-III, DSSSB reserves the right to rectify errors and omissions if any detected at any stage.
