Subject:- Declaration of Marks of offline examination held on 03.11. 2019 for the Post of Post Graduate Teacher (Sanskrit) Post Code-34/12 – regarding.

This notice is issued in supersession of earlier Notice No. F. No. 222/Result/PGT (Sanskrit)/Int. Cell/DSSSB/2019-20/365-73 dated 16/01/2020.

2. The DSSSB vide its advertisement No. 02/12 had advertised **01 {UR-1}** for the post of **Post Graduate Teacher (Sanskrit) in Department of Social Welfare under Post Code-34/12**. Tier-I offline written examination was held on 03.11.2019.

3. The marks obtained by 01 candidate who duly appeared in examination conducted **(offline mode) on 03.11.2019** have been uploaded on the Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.

4. Based on the performance in Tier-I written examination, only 01 candidate as informed in his OARS module has been provisionally shortlisted to appear in Tier-II examination subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in his online application forms. The shortlisted candidate shall be called for Tier-II examination separately.

5. Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitle them any right over the post.

6. Reserved category candidates who have obtained marks above or equal to last shortlisted UR candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, otherwise for selection in their respective category, subject to availability of vacancies.

7. As per the Board Notice dated 26/04/2013, the minimum qualifying marks in One Tier written examination for UR category candidate is 40%, for OBC candidate is 35% and for SC/ST/PH is 30%.

8. The shortlisted candidates for the above mentioned post code will be informed separately for appearing in the Tier-II written examination shortly.

9. While every care has been taken in preparing the list of shortlisted candidates for Tier-II examination, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

10. The above shortlisting candidates for Tier-II examination to the post of Post Graduate Teacher (Sanskrit) under post code-34/12 in Deptt. of Social Welfare is subject to outcome of pending court case, if any.
