Sub: Releasing of marks and calling of e-dossiers for the post of Veterinary and Livestock Inspector in Animal Husbandry Unit under Post Code 09/24.

1. The DSSSB vide its advertisement No. 05/24 read with corrigendum dated 08.07.2025 had advertised Total-52 vacancies including ExSM-05, Sport Person-02 & PwBD cat (b)-01 & cat(c)-01 [UR-17, EWS-05, OBC-26, SC-04] for the Post of Veterinary and Livestock Inspector under Post Code- 09/24 in Animal Husbandry Unit.
2. The Online examination was conducted on 11.12.2025 and a total of 1794 candidates appeared. The marks statements of the above post code have been uploaded on the Board's website. Candidates can view their marks by logging on to their account in OARS module on www.dsssonline.nic.in
3. Based on the performance in the Online examination a total of **Total-101 candidates** who obtained marks above or equal to cut-off marks in their respective category, as detailed below, have been provisionally shortlisted to upload their requisite documents in e-dossier through the OARS module. All the 101 shortlisted candidates for the above mentioned post code are hereby directed to login to the e-dossier module and upload all the documents of education certificates/marksheets/Category-Sub category certificate/Admit cards/proof of Govt. servant/Ex Serviceman/PwBDCertificate/EWS Certificate etc., as applicable, in the e-dossier module in OARS link in their individual accounts in OARS module.

4. As per the examination scheme, the mandatory minimum qualifying marks in Tier-I Examinations will be applicable only in r/o Section-B which is domain subject specific. There will not be any minimum qualifying marks in Section-A. However, combined aggregate marks of both Section-A (100 marks) & Section-B (100 marks) will be reckoned for preparing the final merit list.
5. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.
6. As per the Advertisement/Board Policy, the minimum qualifying marks in one Tier written examination for UR / EWS Category Candidate is 40%, for OBC candidate is 35%, for SC / ST/ PwBD Category Candidate is 30% and for ExSM Will be given 5% relaxation in their respective Categories subject to a minimum of 30% and for Sport Person will be given age relaxation in their respective categories as per advertisement.

7. Kindly note that the e-dossier link will be activated in r/o only those candidates who are provisionally shortlisted to upload e-dossier as per details given in Para 03 above.
8. All the candidates who have been shortlisted for uploading e-dossier **MUST** upload their all requisite/applicable documents in the said link within the stipulated time period.
9. The e-dossier link shall be active from 14.04.2026 to 28.04.2026. The candidate uploading e-dossier should ensure that he/she fulfils all the eligibility criteria/all essential qualifications as per RRs for the said post as on closing date of application i.e. 17.04.2024.
10. The above short-listed candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID **as an additional facility**. If any candidate fails to upload the e-dossier during the above period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
11. Further, in case the candidates are unable to upload the documents within above stipulated time period due to any technical glitch in OARS module, they may report the same alongwith supporting evidence such as screenshots to e-mail of DSSSB helpdesk i.e. **helpdesk-dsssb@delhi.gov.in** within next 48 hours (after expiry of e dossier submission period). The technical glitch shall be substantiated/ verified and only then, an additional period of three days will be granted for uploading the documents in e-dossier system.
12. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfils all the requisite eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he will not be given any further opportunity and his/her candidature will be treated as cancelled.
13. The above short-listing for calling of e-dossier for the above post under Post Code- 09/24 in Animal Husbandry Unit will be subject to outcome of pending court cases OA No. if any.
14. While every care has been taken in preparing the above shortlisting, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
