Further vide result notice number 395 dated 16.6.2016 candidature of 01 candidate for the post of Assistant Superintendent under postcode 38/13 having roll number 13001601 in EXSM Category was kept pending for want of complete documents from the candidate, the candidate is also directed to furnish his relevant and applicable document in e-dossier link.
4. Kindly note that the e-dossier link will be activated to only those candidates who have qualified the PET.
5. All the candidates who have been shortlisted MUST upload their all requisite/applicable documents in the said link.
6. The e-dossier link shall be active from 14.05.2018 to 28.05.2018.
