NOTICE NO.:-1300 STENOGRAPHER (HINDI) (POST CODE 07/20) IN DELHI TRANSPORT CORPORATION

- 1. The DSSSB vide its Advertisement No. 01/20 with closing date 06/02/2020 had advertised **06** vacancies **(UR-05, OBC-01)** for the post of STENOGRAPHER, (HINDI) in DELHI TRANSPORT CORPORATION (DTC) under Post Code 07/20. Board Conducted Tier-I written examination for recruitment in respect of this post on 08th August, 2021.
- 2. The prorated marks obtained by **1169** candidates who have duly appeared in written examination (online mode in single shift, shift-3) held on **08/08/2021** have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dsssbonline.nic.in
- 3. Based on the performance in Tier-I written examination (online mode), out of these 1169 candidates, total 104 (One Hundred Four) candidates (UR-87, OBC-17) as detailed below, have been provisionally shortlisted to appear in Skill Test/Short Hand and Typing Test (fixed, 100, as per policy of the Board) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The candidates have been shortlisted proportionately (83 candidates for 05 vacancies in UR category and 17 candidates for 01 vacancy in OBC Category). Further, as per policy 04 more candidates have been shortlisted in UR category who have obtained marks equal to the marks obtained by the last shortlisted candidate in UR Category. The shortlisted candidates shall be called for Skill Test/Typing Test separately.

- 4. Only those candidates have been considered in OBC Category who has declared that they are OBC (Delhi) in their online application form.
- 5. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Skill Test/Typing Test does not entitled them any right over the post.
- 6. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final



selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.

- 7. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in one Tier written examinations for UR Category Candidate is 40%, for OBC Candidate is 35%.
- 8. The qualified candidates for appearing in Skill Test/Short Hand and Typing Test have been called in fixed number (100 fixed, on proportionate to notified vacancies in UR and OBC Category); however all the candidates who have score marks equal to the cut off marks in UR category have been shortlisted.
- 9. The details of skill/Short Hand and Typing test shall be notified separately by the Board. The candidates are hereby advised to check the website of the Board regularly.
- 10. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
