**NOTICE NO. 138**

**Subject: - Notice to declare Result for Skill Test held on 04.03.2022, 05.03.2022 and 06.05.2022 and calling of E-dossiers for the Post of Junior Stenographer (Eng), Post Code 23/21.**

1. The DSSSB vide its advertisement no. 01/21 with closing date 14/04/2021 had advertised 13 (Thirteen) vacancies (EWS-01, UR-08, OBC-03, SC-01 including EXSM -01 and PwD(HH-01,VH-01)) for the Post of **Junior Stenographer (Eng)** in DSIIDC under **Post Code 23/21** and the written examination (online mode) Tier-I for recruitment in respect of this post was conducted on 26th November, 2021.
2. On qualifying Written Examination, vide Notice No. 97 dated 07/01/2022, the DSSSB shortlisted 151 candidates for appearing in Skill Test for the post of Junior Stenographer (Eng) under Post Code 23/21. The Skill Test for 150 candidates was scheduled on **4<sup>th</sup> and 5<sup>th</sup> March, 2022**, wherein, 104 candidates appeared. 50 candidates have qualified the Skill Test conducted on 4<sup>th</sup> and 5<sup>th</sup> march, 2022. Skill Test for one PH-VH candidate was conducted on 06.05.2022 and the candidate was absent.

The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-

dossier module in OARS link in their individual accounts in OARS module. Short listing is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and being also qualified in skill test.

6. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 4 above.
7. All the candidates who have been shortlisted for falling in consideration zone of selection **MUST** upload their all requisite/applicable documents in the said link in stipulated time.
8. The e-dossier link shall be active from **31/05/2022 to 14/06/2022**. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., **14/04/2021**.
9. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID **as an additional facility**. If any candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
10. All the candidates who have been shortlisted for uploading e-dossiers **MUST** upload their all requisite/applicable documents in the said link in stipulated time i.e., **31/05/2022 to 14/06/2022**.
11. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above, he/she will not be given any further opportunity and his candidature will be treated as cancelled.
12. The above short listing of candidates for calling of e-dossier for the post code -23/21 will be subject to outcome of pending court cases, if any.
13. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
