The candidate having Roll No. 12321501908 for the post of Assistant Teacher (Nursery), Post Code-16/19 had uploaded his/her e-dossier with deficient documents and his/her candidature was rejected for having requisite qualification after cutoff date. The candidate had submitted a representation dated 17.08.2021 & 06.09.2021 stating that she could not be given any opportunity to upload the deficient documents in the e-dossier and requested to give him an opportunity to upload the deficient /requisite documents in the e-dossier.

On scrutiny of the record & OARS module, it has been found that she could not be given any opportunity to upload the deficient documents in the e-dossier and accordingly, he/she is being given 1st opportunity w.e.f. 05.04.2022 to 14.04.2022 to upload the documents as per details given below:-

1	12321501908	The candidate has uploaded Diploma in Pre-School Education after cutoff date i.e. 09.07.2020 whereas B.Ed. (Nursery) or 2 years certificate /Diploma in Nursery Teacher Education Program as on cutoff date required as per RRs. He / She is being given 1 st opportunity w.e.f. 05.04.2022 to 14.04.2022 to upload the deficient /requisite documents in the e-dossier.

- The above candidate is directed to upload his/her deficient documents, through the e-3. dossier module w.e.f. 05.04.2022 to 14.04.2022.
- The e-dossier link shall be activated to the above pending candidate 4. only for a period of 10 days w.e.f. 05.04.2022 to 14.04.2022
- The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility 5. criteria as on the cutoff date, i.e 15.10.2019 as per Advertisement No. 03/2019.
- Mere asking the candidate for uploading documents in the e-dossier module does not 6. confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
