1. The DSSSB vide advertisement No. 10/2024 dated 30/12/2024 had advertised total **61 Vacancies** {50 vacancies (Male) (UR-28, EWS-04, OBC (D)-10, SC-06, ST-02 including PwBD- 01 (d&e) category}, {11 vacancies (Female) (UR-02, EWS-03, OBC (D)-04, SC-01, ST-01 including PwBD - 01 (d & e) category} for the post of PGT (History) (Male/Female) in Directorate of Education, GNCTD, {No Requisition received till date} in New Delhi Municipal Council under Post code - 831/24.
2. Online written examination (Tier-I scheme) was held on 22.09.2025.
3. The marks statement of **4111** candidates who appeared in Tier-I written examination (online mode) were uploaded on OARS module of the Board's website and **162** candidates as per their merit were provisionally shortlisted and asked to upload their e-dossier w.e.f. **29/04/2026 to 13/05/2026** in OARS module vide notice dated **29.04.2026**.
4. As per the advertisement under Combined Examination Scheme, it has to be ensure that – **The Candidate must exercise at least one preference for a post. Candidates who do not submit their post preference(s) within the stipulated time, will not be considered for any post in the final result. Such candidates shall not be provided with another opportunity to exercise preference for posts. Further, "Final selection and allocation of department by DSSSB shall be based on merit cum preference only. The User Department shall check the eligibility as per RRs and other terms and conditions of the Advertisement Notice.**
5. The result has been processed purely on the basis of marks obtained by the candidates in the Tier-I examination held on **22.09.2025** and also claims made by the candidates in their online application forms of the **Post of PGT (History)- Male in Directorate of Education, GNCTD, PGT (History)- Female in Directorate of Education, GNCTD under Post Code – 831/24**. The Board has not undertaken scrutiny of documents uploaded in the e-dossiers at this stage, as per Board's resolution / decision dated 14.07.2022. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement number 10/24 and relaxations as per rules in respect of educational qualifications, age experience, etc., shall be scrutinized/ verified by the User Department for determining eligibility of the

candidates for the post code – 831/24 as on cutoff date i.e. 14/02/2025 before issuance of offer of appointment to the post.

6. On the basis of marks secured in the written examination (Tier-I scheme) and considering other relaxations, if any, claimed by the candidates in their online application forms, the candidates having following Roll Nos. (One Tier-Technical/Teaching) are hereby provisionally nominated for the post of **PGT (History) - Male in Directorate of Education, GNCTD, PGT (History) -Female in Directorate of Education, GNCTD, under Post Code – 831/24** subject to fulfillment of all other conditions of eligibility and also correctness of the information furnished by the candidates in their online applications forms and e-dossiers:

6. The provisional nomination of the above **61 Vacancies {50 vacancies (Male) (UR-28 inclu. PwBD (d&e)-01, EWS-04, OBC-10, SC-06, ST-02}, {11 vacancies (Female) (UR-02 inclu. PwBD (d&e)-01, EWS-03, OBC-04, SC-01, ST-01)}** for the post of PGT (History) in Directorate of Education, GNCTD under Post code - 831/24 are on the basis of their claims in their applications shall be subject to thorough verification of their candidature by the User Department including the identity of the candidates as per services department Circular No. F.16(3)/2007/S-III/1756-1763 dated 02/08/2021.

7. The provisional nomination of the above **61 Vacancies {50 vacancies (Male) (UR-28 inclu. PwBD (d&e)-01, EWS-04, OBC-10, SC-06, ST-02}, {11 vacancies (Female) (UR-02 inclu. PwBD (d&e)-01, EWS-03, OBC-04, SC-01, ST-01)}** for the post of PGT (History) in Directorate of Education, GNCTD under Post code - 831/24 shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement and subject to thorough verification of his identity with reference to their photographs, signature/ handwriting etc. on the application form, admission certificate etc. by the User Department. The candidature of the candidates are liable to be cancelled by the User Department, in case, candidates does not fulfill any of the eligibility conditions of the Recruitment Rules for the post or for any genuine reason. The decision of the User Department regarding the eligibility of the candidates shall be final and binding on the candidates. The Competent Authority of the User Department concerned shall issue the offer of appointment to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential qualifications.

8. The User Department shall also check the eligibility of the reservation benefit claimed by the candidates, if any. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate, if applicable. The Competent



Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User Department is requested to ascertain the scrutiny/correctness of the same at its own level before issuing the offer of appointment to the provisionally selected candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at its own level.

9. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22/93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.

10. The User Department shall also get the SC/ST/OBC/EWS/PwD (with sub category) certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017 and other instructions/ guidelines issued from time to time by the competent authorities.

11. Further, in case of EWS candidates, it may also be verified that the validity of EWS certificate should be as per DOPT OM No. 36039/1/2019-ESTT(Res) dated 31.01.2019 and other instructions/ guidelines issued from time to time in this regard by the competent authorities.

12. At this stage, DSSSB has not undertaken the veracity/scrutiny of experience certificates furnished by the candidates. As such User Department i.e. Directorate of Education, GNCTD & NDMC will ascertain the equivalence/scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidates. The nomination by DSSSB is provisional and subject to the satisfaction of User Department.



13. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after verification of the correctness of the information furnished in the application form/e-dossier and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54.

13. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

14. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
