SUPPLYMENTARY RESULT NOTICE NO. 1609
JUNIOR CLERK (POST CODE 13/20)
IN DELHI TRANSPORT CORPORATION (DTC)

1. The DSSSB vide its Advertisement No. 01/20 with closing date 06/02/2020 had advertised **254** vacancies (**EWS-25, UR-104, OBC-68, SC-38, ST-19 including OH-03, HH-03, VH-04**) for the post of Junior Clerk in Delhi Transport Corporation under Post Code 13/20. Board conducted Tier-I (G) written examination for recruitment in respect of this post in the month of **November, 2021**.
2. The Board has shortlisted 2113 candidates on qualifying Written Examination vide Notice No. **1348 dated 18/01/2022** for appearing in Skill Test/Typing Test for the post of Junior Clerk under Post Code 13/20. The Skill Test was conducted in May & June 2022. Only 1507 candidates appeared for the test out of 2113 candidates and only 1175 candidates could qualify in Skill Test.
3. The Skill Test result of 1175 qualified candidates was declared on the Board's website vide Notice No. 1405 dated 18/07/2022 and e-dossiers were called from 560 shortlisted candidates as per details mentioned in the said notice between 22/07/2022 to 05/08/2022.
4. DSSSB vide Result Notice No. 1413 dated 13.09.2022 & its corrigendum notice no. 1411 dated 13.09.2022, had provisionally nominated **253 candidates (UR-96, EWS-23, OBC-68, SC-37, ST-19, OH-03, HH-03 & VH-04)** and also provisionally nominated **52 candidates (URWL-19, EWSWL-05, OBCWL-14, SCWL-07, STWL-04, OHWL-01, HHWL-01 & VHWL-01)** for the post of Junior Clerk in Delhi Transport Corporation under Post Code 13/20, purely on the basis of marks obtained by the candidates in the written examination and also claims made by the candidates in their online application forms for the post, as per the Board's resolution dated 14/07/2022.
5. Further, in view of the direction of the Hon'ble CAT passed vide Order dated 16.10.2025 in OA No. 4771/2024 in the matter of Sh. Kuldeep Vatsa Vs GNCTD & Ors., the DTC has requested for provision of **154 e-dossiers (UR-61, EWS-21, OBC-35, SC-23, ST-14 including OH-01, HH-02 and VH-03)** from the reserve panel against the 196 candidature cancellation under post code 13/20.
6. In compliance with the directions of the Hon'ble CAT and in view of the request received from DTC, the following additional **153 candidates [UR-49, EWS-21, OBC-41, SC-22, ST-14, OH-01 (UR), HH-02 (UR-01, SC-01), VH-03 (UR-02, EWS-01)]** are hereby provisionally nominated from the reserve panel of their respective categories under Post Code 13/20, purely on the basis of marks obtained by them in the Tier-I examination, in accordance

with the Board's Resolution dated 14.07.2022. The User Department is requested to utilize the same, in conformity with DoPT guidelines and instructions of Govt. of NCT, Delhi issued from time to time and also mentioned in the result Notice of the post code:-

- The candidature of 06 candidates having roll nos. 412013023355, 315013006803, 323013001717, 412013025597, 412013008739 and 319013007167 earlier nominated in OBC category now shifted to the UR Category. Further, candidature of 01 candidate having roll no. 411013002216 earlier nominated in EWS category now shifted the UR category, as per their merit in the post code 13/20.
- The Selection of the above **153 candidates [UR-49, EWS-21, OBC-41, SC-22, ST-14, OH-01 (UR), HH-02 (UR-01, SC-01), VH-03 (UR-02, EWS-01)]** shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the User Department in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, age and other essential certificates.
- The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. DTC shall**

verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
11. The User Department shall also get the SC/ST/OBC/EWS/PH certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No.36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No.36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 and 13/09/2017 and other instructions/guidelines issued from time to time by the competent authorities.
12. Further, in case of EWS candidates, it may also be verified that the validity of EWS Certificate should be as per DoPT OM No. 36039/1/2019-ESTT(Res) dated 31/01/2019 and other instructions/guidelines issued from time to time by the competent authorities.
13. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
15. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is

satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
