ORDER

In compliance of the final orders of Hon'ble CAT dated 20/03/2015 passed in the aforementioned case of para (5) of which reads as under:

"We dispose of the aforementioned Original Applications with liberty to the applicants to make individual representations to the Board within one Week from today and a direction to the Board to decide the same within three weeks thereafter by way of reasoned and speaking order. It is made clear that the time limit of three weeks is outer limit for disposal of the representations and in such cases where the dates of interview have been finalized the respondents may consider the representation of priority No Costs".

The applicants were allowed one week time to resubmit their representation to the Board vide order dated 20/03/2015. The petitioner has submitted her representation.

In view of the above direction of the Hon'ble court, representations of the candidate have been examined and the reasons for rejection of the applications are as under:

1. Ms. Meena Kumari submitted her representation on 31/03/2015 that she had applied for the post code 111/12 TGT (Maths) Female & 09/13 TGT (Maths) Female.
2. As per record, there is no Application No./ID No. generated in respect of Ms. Meena Kumari against the post code 111/12 of TGT (Maths) Female as she did not finally submit her application in OARS of the Board. As such she is not a candidate for post code 111/12, TGT(Math)(Female).

3. Candidates for the post code 09/13 TGT(Maths) are required to submit application form on OMR. Candidate had submitted her application on the prescribed application form but has not bubbled column No. 13(2) Degree/Diploma in Training Education or SAV certificate and working knowledge of Hindi which are very important columns for the candidates for post code 09/13. Hence her application has been rejected on the preliminary stage by the OMR scanner.

In view of above, the candidature of above said candidate in both the post codes stand rejected.

This issues with the prior approval of Competent Authority.
