ORDER

Sub: <u>Compliance of Order/ direction of the Hon'ble CAT passed in OA</u>
NO.3156/2012 titled as Dr. Pradeep Kumar Goswami Vs GNCTD and Ors.

The Hon'ble CAT in OA No.3156/2012 titled as Dr. Pradeep Kumar Goswami Vs GNCTD and Ors. has passed the following order which is reproduced as under:

"5. We have heard counsel for the applicant and perused the documents on record. We notice that the impugned order is not a speaking one and as no reasons whatsoever have been given by the DSSSB while stating that no candidates were found eligible/suitable for selection to the post of Ayurvedic Compounder. We, therefore, we dispose of this OA at the admission stage itself with the direction to the DSSSB to give a reasoned and speaking reply to the applicant explaining as to why name of the candidates was found eligible or suitable for selection to the aforesaid post within the period of one month from the date of receipt of a copy of this order. There shall be no order as to costs."

In compliance of the above direction of the Hon'ble CAT, the case of Dr. Pradeep Kumar Goswami has been re-examined. In this regard it is to say that as per RRs, the Essential Qualifications and Experience for the post of Ayurvedic Compounder under post code 0023 was as under:-

Essential Qualifications:

- a) Matriculation or equivalent.
- b) Training in Upavaidya (Kalpad) course, duration of which should not be less than two years from a Government organization or recognized private institution like All India Ayurvedic Congress or its equivalent..

OR

Training in one of the following courses

 i) Vaidya Vishard (As per letter No. 4521/AO (H)/DK/2005 dated 19-05-2005 of Addl. Dy. Commissioner (Health), MCD the qualification stands de-recognized).

ii) Ayurved Vishak (Awarded by All India Ayurvedic Congress).

iii) Ayurved Rattan* (Awarded by Hindi Sahitya Sammelan). *As per letter

No.4521/AO(H)/DK/2005 dated 19-05-2005 of Addl. Dy. Commissioner(Health), MCD

the qualification stands de-recognized.

c) At least two years experience as Ayurvedic Compounder in a recognized Ayurvedic

dispensary, Hospital or Pharmacy.

Sh. Pradeep Kumar Goswami , Roll No. 23143753 has done BAMS in November, 1996

from Delhi University and has got no experience as an Ayurvedic Compounder from a

recognized Dispensary, Hospital or Pharmacy as on the cut-off date i.e. 30-06-2003. As such,

his Essential Qualifications/Experience is not in conformity with the RRs provided for the said

post. Hence he was not found eligible for the post of Ayurvedic Compounder, Post Code 0023.

Further, it is informed that the DSSSB is a recruiting agency and it has to process the result of

any post code on the basis of Essential Qualification/Experience and other eligibility conditions as

provided in the RRs of the post code. In the instant case, since the applicant was not having

Essential Educational Qualifications and Experience as per RRs of the post of Ayurvedic

Compounder, Post Code 0023, hence, he was declared as not eligible and was not selected for the

said post.

This issues with the approval of the competent authority, DSSSB.
