ORDER

This order shall dispose of the representation of Sh. Govind Ram, dated 11.04.2018 in compliance of the directions of Hon'ble CAT order dated 29.05.2018.

2. The applicant in his application before the Hon'ble CAT has prayed that he submitted a representation in DSSSB on 11.04.2018 and a direction be issued to the respondents to decide the aforesaid representation of the applicant within a specified time.

3. The Hon'ble CAT vide order dated 29.05.2018 has directed that the representation of the applicant dated 11.04.2018 be decided within two months from the date of receipt of a certified copy of this order.

4. Sh. Govind Ram had applied for the post of TGT (Computer Science), Post Code-192/14 under UR category. The applicant scored 71.75 marks. The last candidate nominated under this category scored 98.50 marks. Since the applicant was not falling within the zone, his candidature under UR category could not be considered.

5. The applicant in his representation dated 11.04.2018 stated that he is residing in Delhi since 2006 and belongs to OBC category. Since he was not having the OBC certificate at the time of applying for the post of TGT (Computer Science), he applied for the said post under UR category.

6. He further stated that the last candidate provisionally nominated under OBC category scored 68.6 marks. Since the applicant scored 71.25 marks, his candidature should be considered under OBC category as he obtained OBC certificate issued by the Competent Authority.

7. He has also stated that out of 547 notified vacancies under OBC category, 140 posts are still lying vacant and it is the duty of the DSSSB to fill up all the notified vacancies, more so, the applicant is in possession of OBC certificate and he is an OBC candidate even at the time of cutoff date and the mere technicality of applying under UR category cannot result into robbing of the rights of an OBC candidate.

8. As per the guidelines of Revenue Department, Govt. of NCT of Delhi the eligibility criteria for issuance of OBC (Delhi) certificates is as under:-

- ✓ An individual who is a citizen of India
- ✓ OBC certificate has already been issued to any paternal blood relative (Father/Uncle).
- ✓ An individual who is a permanent resident of Delhi on or before 8th September, 1993.
- ✓ Caste applied for must be notified in Govt. of NCT of Delhi

9. The applicant is a migrant and in his own admission, he stated that he is residing in Delhi, since 2006. Moreover, scrutiny of the OBC certificate dated 01.03.2018, enclosed with the representation dated 11.04.2018, revealed that the same was issued by Tehsildar, Sarita Vihar on the basis of OBC certificate issued to his paternal uncle, Sh. Avdhesh Kumar who is a permanent resident of Farukkhabad, Uttar Pradesh. As such, he is not OBC (Delhi).

10. It is further clarified that the candidate had applied for the post under UR/Gen. category in OARS (Online Application Registration System). As per Board's policy, the candidature of the candidates is considered in the applied category only and no change in category is allowed. Further, even if he applied under OBC category, he would not have been given the benefit of OBC (Delhi) for the reason explained above.

11. The candidate's claim for considering him under OBC (Delhi) category is void of Delhi Government's policy and, therefore, cannot be acceded to.

12. This issues with the approval of Competent Authority and in compliance of the directions of Hon'ble CAT.

13. Let this order be served upon Sh. Govind Kumar.
