## **ORDER**

A representation has been received in the Board on 02-09-2015, submitted by Sonia Mann D/o Ram Kumar Mann R/o H.No. 244, Village and Post Office Khera Khurd, Delhi-110036, citing the order dated 20-03-2015 in OA No. 4703/2014 Kavita & Ors. Vs. GNCTD, requesting for a decision in the matter. In the said judgement, the following directions were issued to the respondents i.e. DSSSB:-

"In the circumstances, we dispose of the aforementioned Original Applications with liberty to the applicants to make individual representations to the Board within one week from today and a direction to the Board to decide the same within three weeks thereafter by way of reasoned and speaking order. It is made clear that the time limit of three weeks is outer limit for disposal of the representations and in such cases where the dates of interview have been finalized the respondents may consider the representation of priority No Costs".

As per the order, the applicants were allowed one week's time to submit their representation to the Board. Sonia Mann is claiming to have filed her representation in DSSSB within time. As per record available, no representation was received from the applicant within the stipulated time. However, a representation dated 02-09-2015 was received from the applicant. The brief facts of the case are:

- As per advertisement notice number 02/2012, DSSSB invited applications for filling up of vacant posts of various categories of post codes 02/12 to 165/12. Candidates were advised to read the detailed instructions in Sections A, B and C of the advertisement before filling up Part-I and Part-II of the application form strictly according to the instructions.
- 2. As per notice dated 24-10-14 and subsequent notices dated 25-11-14 etc., the candidates were informed that since the Board had switched over to OARS, the applicants who had applied for the said post codes through paper based forms were required to get themselves registered in OARS software and to upload their photograph, signature and educational qualification/experience online for issuance of admit cards through OARS. Candidates were also advised to ensure that they fulfill all the eligibility criteria as per the advertisement no.02/12 on or before the cut-off date.
- 3. Thereafter, as per advertisement notice number 01/2013, DSSSB again invited applications for filling up of vacant posts of various categories of post codes 01/13 to 23/13 which also included post code no. 13/13. Candidates were advised to read the detailed instructions in the advertisement before filling up the Optical Mark Reader (OMR) application form strictly according to the instructions. It was pointed out as per instruction No.9 of the advertisement notice "that the application forms with any of the following deficiencies or irregularities will be treated as invalid and summarily rejected:
  - a) Application form not in prescribed OMR Format or Application form in Newspaper cutting or submitted before opening date or after closing date.
  - b) Post Name and Post Code(s) not filled up or incorrectly filled up.
  - OMR application form not filled up or not filled up as per direction given in the Notice.
  - d) Incomplete or illegible or incorrectly filled up applications
  - e) Without passport size coloured photograph (front face) with light background affixed on application form in the space provided. Affixing Black and

White/polaroid and blurred photographs. Affixing more than one type of photograph.

- f) Without signature and left hand thumb ink impression in space provided.
- g) The application filled up in other than Blue/Black ball pen.
- h) Signature done in Block/Capital letters in English or in different languages and in different style/mode or any variance in the signature.
- i) The Left thumb ink impression not clearly visible.
- j) Applications not filled in by candidate in his/her own handwriting.
- k) Under/over aged candidates.
- I) Not having the requisite qualifications as on closing date.
- m) More than one application for the post by the post by the same candidate for the same post.
- n) Applications of more than one candidate or more than one post code sent in one envelope.
- Application from a candidate debarred from appearing in the Exam by the DSSSB/SCC for life time or for a particular period.
- p) Any other irregularity

NOTE: No claim for re-consideration of the rejected cases on the grounds specified above will be entertained. Original document/ certificates are to be produced along with self- attested copies at the time of verification of documents only."

The representation of the applicant dated 02-09-2015 has been considered and is rejected on the following grounds:

- That the applicant failed to bubble the relevant column regarding possession of requisite qualification in the OMR application form and thereby failed to comply with the instructions given in the examination notice number 01/13 while filling up the application form. As the OMR forms are machine readable, the same was rejected due to the reasons "Not having the requisite qualification as on closing date."
- 2. That the applicant failed to file her representation within the stipulated period of one week of the order dated 20.03.2015.

In view of the above, the candidature of the applicant stands rejected.

This issues with the prior approval of Competent Authority.
