ORDER

Subject: In compliance Ld. CAT order dated 19.01.2018 in the matter of Hoshiyar Singh Vs. DSSSB & Ors in O.A. No 4081 of 2017,

1. Whereas Ld. CAT vide their order dated 19.01.2018 in the matter of Hoshiyar Singh Vs. DSSSB & Ors in O.A. No 4081 of 2017,has directed the respondent

"to consider the claim of the applicant for his appointment to the post of TGT(SST) Male under post code 09/10 on the basis of his merit in the examination for the said post, and if there is any deficiency of verification of the documents, the same may be communicated to the applicant within two weeks. The applicant shall submit all documents within two weeks thereafter, and if on the merit of the applicant he is found entitled to be selected/ appointed, consequential orders shall be issued for this purpose with in a period of two weeks thereafter. Needless to say that the applicant would be entitled to seniority as per her merit in the selection process. However, the financial benefits would be available to the applicant from the date of her appointment." The O.A. stands disposed off with the above direction.

- 2. And whereas, the applicant Sh. Hoshiyar Singh has applied for the post of TGT SST (Male) under post code 09/10 to whom the Roll No. 5912708 was allotted.
- 3. And whereas, for post code-09/10 and 59/10, Part-I examination (combined examination) was conducted on 08.04.2012, 29.04.2012 and 12.05.2012, wherein the applicant had scored 48 marks out of 100 and was short listed for post code 09/10 in SC category for evaluation of Part-II examination answer-sheet, for which the cut off marks were 47 in Part-I examination.

- 4. And whereas, the Part-II combined examination was also conducted on the same date i.e. on 08.04.2012, 29.04.2012 and 12.05.2012. The applicant has obtained 74 marks in Part II examination. The final result was declared on the basis of marks of Part-II examination.
- 5. And whereas, result for the post of TGT (SST-Male) under postcode 09/10 was declared vide Result Notice No. 412 dated 18.07.2016, Result Notice No. 462 dated 06.01.2017 and Result Notice No. 530 dated 10.07.2017 whereby the Board has selected 57 candidates. The marks of the last selected candidate in UR category were 90. And the marks of the last selected candidates in SC category were 77.
- 6. Whereas, it is clear that candidate was not selected in SC category for the post of TGT (SST-Male) under post code 09/10 being lower in marks.
- 7. Further, with regard to the post code 59/10, it is submitted that marks of the last short listed candidate in Part-I in SC category for evaluation of Part-II examination answer-sheet were 51 marks, whereas the applicant has obtained 48 marks only. Therefore, the applicant was not short listed for Part-II for the post code 59/10.
- 8. Further, as per Board letter dated 28/12/2017 the Board has closed the selection process for postcode 09/10 and returned the 143 (123-UR, 07-OBC, 07-SC & 06 ST) unfilled vacancies to the user department.
- 9. Furthermore, at the time of declaration of result on 18.07.2016 the Board has kept a waiting/ panel list of three candidates in post code 09/10 as per the order dated 13.03.2013 a reserve panel waiting List upto the extent of 10% of the notified vacancies were drawn. The name of the applicant was not included in those three candidates being lower in merit.
- 10. Regarding effectiveness of reserved panel/wait list it is submitted that the reserved panel/waiting list is valid for a period 1 year from the date of declaration of result. Accordingly, the validity of the waitlist/panel has expired on 17/07/2017.



- 11. Therefore, in light of above facts and circumstances, the claim of the applicant, Hoshiyar Singh having Roll No. 5912708 for consideration of his candidature under postcode 09/10 cannot be considered being lower in marks/merit than the last selected candidate for the post of TGT (SST-Male) in SC category. Further, the Board is unable to consider his claim as the selection process for the postcode has been closed with unfilled vacancies returned to the user department and the validity of the waitlist/panel of the postcode has expired, and moreover there are 08 SC candidates above the merit position of the applicant. Accordingly the candidature of the applicant will remain as not selected.
- 12. This issues with the prior approval of Chairperson, DSSSB.
