ORDER.

The Ld.CAT vide its order Dt. 13/08/2015, in OA.No. 3006/2015, M.A. No. 2643/2015, titled Ashwini Kumar Singh V/S the Secretary, DSSSB, directed to examine the claim of Sh.Ashwini Kumar Singh to the post of PGT (Economics), in pursuance of the same the following is informed.

Whereas the Board had advertised 19 vacancies (UR-10, OBC-06, SC-03 including VH-01) for the post of PGT (Economics) under post code 31/10 in Dte. Of Education vide its Advt. No.002/2010. The part I result was declared on 09/03/2012 vide result notice No. 261, Dt. 09/03/2012 in which total 120 candidates were shortlisted.(UR-63,OBC-33,SC-20&PH(OH)4) in respect of post code 31/10. On the basis of Marks secured by them in Part. II examination, Descriptive (Main) the merit list of 28 candidates were prepared and from this merit list 09 candidates (UR-03, OBC-03, SC -02, & UR/OH-01) were provisionally selected. The result of 02 candidates in UR category were kept pending due to various reasons under Post code 31/10 vide result Notice No. 289, Dt. 17/08/2012.

And Whereas, Sh. Devender Singh, Roll. No.03111326, (DOB-30/01/1971) had applied under UR/GS category. Therefore he was eligible for 5 years relaxation due to Govt. Servant, and he was declared for provisional selection in UR category.

And Whereas out of these 02 (Two) pending candidates one candidate was provisionally selected vide office order No. 310, Dt. 13/02/2013 and other candidate was found not eligible vide order No. 312, Dt. 13/02/2013. Further at that time there was policy by which no waiting panel/list was prepared and kept valid. This policy ~~had~~ continued to be followed by the Board before the notification Dt. 13/06/2013. The recruitment process in the given post code No.31/10 stand closed with the approval of the competent authority and vacancies of the Post code was intimated to user Department. In the above mentioned circumstances the candidature of Sh.Ashwini Kumar

Singh under post code 32/10, PGT (Eco) cannot be considered and hence rejected.

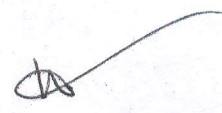
This issues with the prior approval of the competent authority.
