ORDER

SUB: Compliance of order dated 19.01.2023 passed by the Ld. CAT in OA No. 1340/2016 in the matter of Sukantla vs. GNCTD & Ors.

WHEREAS, the Ld. CAT of Delhi vide its order dated 19.01.2023 in OA No. 1340/2016 in the matter of Sukantla vs. GNCTD & Ors., has directed as under:

- 5. The respondents would thereafter dispose of the same by passing a reasoned and speaking order within a period of six weeks from the date of receipt of the said representation.
- 6. We have not entered into the merits of the case. A copy of the speaking order so passed be given to the applicants".
- WHEREAS, DSSSB invited online applications for total 669 vacancies (UR-242, OBC-237, SC-124, ST-66 (including PH-OH-10 & PH-VH-14) for the post of Special Education Teacher under post code- 146/14, in the Directorate of Education(GNCTD) vide advertisement No 01/14. The Cut-off date/Closing date of application was 27.02.2014.
- AND WHEREAS, Ms. Sukantla applied for the above post code under UR Category and appeared in the examination held on 19.10.2014 vide Roll No 17000857. The marks of candidates were uploaded on Board's website on 30.07.2015. Accordingly, the applicant, candidate had secured 92.50 marks and after scrutiny of dossier, it was found that CTET was not done as per RR's of User Department and she has been rejected vide Rejection Notice No.436 dated 03.02.2016.
- AND WHEREAS, the result process has already been closed on 09.02.2018 and waiting panel has also been expired on 08.02.2019.
- NOW, THEREFORE, the request of the petitioner, Ms. Sukantla, Roll No. 17000857 has been examined, considered and not found admissible in view of the facts mentioned above, hence rejected.
