**ORDER**

**SUB: Compliance of order/direction dated 13.01.2023 of the Hon'ble CAT as passed in OA No. 2649/2021 titled as Dinesh Meena Vs. GNCTD & Other.**

WHEREAS The Hon'ble CAT of Delhi vide its order dated 13.01.2023 passed in OA No. 2649/2021, titled as Dinesh Meena Versus GNCTD & Other, has directed as under:-

***"3. Learned counsel for the applicant, however, adds that the same qualification of Agriculture Statistics is treated to be equivalent to Applied Statistics by the UPSC in various advertisements. He also states that the applicant would be satisfied, if a direction is given to the respondents to dispose of his pending representation dated 08.09.2021 (at page 77) by passing a speaking order within a time period.***

***4. We have heard both the learned counsels. In view of the limited prayer made by the learned counsel for the applicant, the respondents are hereby directed to dispose of applicant's said representation dated 08.09.2021, within a period of 6 weeks from the date of receipt of a certified copy of this order. It is made clear that we have not entered into the merits of the case. O.A. No. 2649/2021 stands disposed of accordingly.***

***5. Associated MAs, if any, also stand disposed of accordingly".***

1. The applicant Dinesh Meena had sent a representation dated 08.09.2021 to Dy. Director (Planning Deptt.) GNTCD, Delhi Secretariat Delhi-2.

2. AND WHEREAS, the brief of the fact is that the DSSSB vide its advertisement No. 01/17 had advertised total 260 vacancies (UR-79, OBC-100, SC-46, ST-35 including PH (OH-02, HH-05, VH-04 & Autism/Multiple disability-05) for the **Post of Statistical Assistant under Post Code 04/17 in Planning Department**. Later on the same were revised vide addendum dated 07.11.2019 and the modified vacancies are total 273 vacancies (UR-88, OBC-102, SC-47, ST-36 including PH (OH-02, HH-05, VH-04 & Autism/Multiple disability-05). The prescribed cut-off date for determining the eligibility of the candidates is the closing date for receipt of applications for the respective post on 21.08.2017.

3. AND WHEREAS, Educational and Other Qualifications as per RRs/Advertisement are as under:

**Qualification, Essential:** Post Graduate Degree in Statistics/ Operational Research/ Mathematical Statistics/ Applied Statistics or Post Graduate Degree in Economics/ Mathematics/Commerce (with statistics as one of the subject/papers in Post-Graduation/Graduation level).

**Note:** The candidate who have passed Statistics as one of the papers/subjects including Quantitative Method/Techniques or Costing & Statistics/Basic Statistics/Business Statistics/ Introduction to Statistics etc. at Graduation/Post Graduation level are also eligible.

**Desirable:** Working knowledge of computers.

4. The DSSSB conducted online examination on 27.11.2019 for the said post code and the marks list of all candidates appeared in the examination was uploaded on Board's website on 16.03.2020.

5. And Whereas, it is stated that the applicant Sh. Dinesh Meena S/o Sh. Ranjeet Meena, (Roll No. 11192200045) appeared in the said exam and secured 77.25 marks and was shortlisted for calling e-dossiers. He uploaded the e-dossier on Board's website. But during the scrutiny of documents, it was noticed that the **applicant has done M.Sc. (Agriculture with agricultural statistics)** which did not appear to be fulfilling the requisite essential qualification as per RRs of User Department.

6. AND WHEREAS, the DSSSB asked for **clarification** vide letter no F. 4(586)/DSSSB/CC-I/2020/ 10931-32 dated 28.01.2021 and user department has clarified vide letter no 9(18)/2020/CC/ Plg/2069 dated 22.02.2021 that the essential qualification as per RRs/Advt. of user department was as under:

**"Post Graduate Degree in Statistics/Operational research/Mathematical Statistics /Applies statistics or Post Graduate degree in Economics/Mathematics/ Commerce (with statistics as one of the subject/papers in Post Graduation /Graduation level).**

**Note: The candidates who have passed statistics as one of the papers/subjects including Quantitative Method/Techniques or Costing and Statistics/Basic statistics/Business Statistics/introduction to Statistics etc at Graduation/Post Graduation level are also eligible.**

**In light of above RRs, it is informed that M.Sc. Agriculture with Agriculture Statistics is not a valid qualification for the said post".**

7. AND WHEREAS, he has been rejected vide Rejection Notice No.1340 dated 25.08.2021 and the result process has already been closed on 28.08.2020 and waiting panel has also been expired on 27.08.2021.

8. Now, therefore, the claim/request of the petitioner, Sh. Dinesh Meena S/o Sh. Ranjeet Meena, (Roll No. 11192200045) has been examined, considered and not found admissible in view of the facts mentioned above, hence rejected.
