ORDER

This order shall dispose of the representation of Sh. Chandra Bhan Sharma (Roll No.52000158) dated 04.10.2017, in compliance of the directions of Ld. CAT order dated 11.07.2023 in OA No.4220/2017 in the matter of Chandra Bhan Sharma Vs. GNCTD.

2. Whereas the Ld. CAT while disposing the Original Application No. 4220/2017 vide its judgment dated 11.07.2023 has directed inter alia, that ***"The respondents are directed to dispose of the pending representation of the applicant dated 04.10.2017 by passing a reasoned and speaking order, within a period of six weeks from the date of receipt of a certified copy of this order"***

4. And whereas the applicant Sh. Chandra Bhan Sharma (Roll No. 52000158) had submitted a representation dated 04.10.2017 and stated that (i) his candidature has been rejected vide notice no. 86 dated 23.09.2016 with the reason that 'failed to upload e-dossier' (ii) No information regarding uploading of e-dossier was received by him through post (iii) allow him in second list to upload e-dossier.

5. And whereas on perusal of the records, it has been found that (i) Sh. Chandra Bhan Sharma has given wrong facts in the representation dated 04.10.2017 as he was not rejected vide rejection notice no. 86 dated 23.09.2016. The rejection notice no. 86 dated 23.09.2013 was issued in respect of those candidates who were called for documents verification in first list of shortlisted candidates whereas Sh. Chandra Bhan Sharma was not called for documents verification in first stage for being lower in merit. Moreover, when the vacancies remained unfilled then more qualified candidates below the last shortlisted candidates were asked to upload e-dossier in OARS portal vide Notice dated 14.07.2017. Sh. Chandra Bhan Sharma was also one of them. (ii) Sh. Chandra Bhan Sharma was asked to upload his documents in the e-dossier vide notice dated 14/07/2017 through usual communication method in second list by giving 15 days time period i.e. upto 28.07.2017 from the date of issuance of notice dated 14.07.2017. The notice dated 14.07.2017 was uploaded on the website of the Board for information of all shortlisted candidates. Further, login ID of each shortlisted candidate was opened during the above period to upload their documents in the e-dossier.

6. And whereas the candidate Sh. Chandra Bhan Sharma was failed to upload his documents in the e-dossier within time period, his candidature was rejected vide Rejection Notice No. 185 dated 13.09.2017 as per Board policy. Moreover, para-3 of notice dated 14.07.2017, it has been clearly mentioned that ***"The candidate who fail to upload their***

documents on or before the date as mentioned above will not be given any further opportunity and their candidature will be treated as cancelled”.

7. And whereas in a similar case, the Hon'ble High Court of Delhi vide its order dated 25.03.2019 in the matter of Pushpendra Singh Parnami Vs. DSSSB & Anr. in WP (C) No. 2892/2019 has also opined that “Having missed the bus, he cannot be permitted to submit his documents/ e-dossiers after the cutoff date. If such relaxation were to be granted to one candidate, it would be discriminatory in respect of others, who may have similarly missed the bus and this would render the entire process undertaken by the DSSSB as open ended”.

9. In view of aforesaid facts, the representations dated 04.10.2017 of the applicant has been examined/ considered in details in compliance of the directions of the Ld. CAT in O.A. No. 4220/2017 dated 11.07.2023 and found that regarding allowing him in second list to upload e-dossier as per representation dated 04.10.2017, he had already been called for uploading e-dossier vide notice dated 04.10.2017 for period and hence no more action is warranted in respect of his representation dated 04.10.2017 hence filed.

This issues with the approval of Chairman, DSSSB.
