ORDER

Sub: <u>Compliance of Order/ direction of the Hon'ble CAT passed in OA NO.3396/2012 titled as Pavitra Sangwan Vs DSSSB and Ors.</u>

The Hon'ble CAT in OA No.3396 of 2012 titled as Pavitra Sangwan Vs DSSSB and Ors. have passed the following direction which is reproduced as under:

4. "In the above facts and circumstances of the case, we dispose of this Original Application with a direction to the respondents to look into the aforesaid representation of the applicant and take appropriate action in the matter as early as possible but in any case within a period of one month from the date of receipt of a copy of this order. There shall be no order as to cost."

In view of the above direction of the Hon'ble CAT, the case of Smt. Pavitra Sangwan has been re-examined. All the eight (08) vacancies have been filled up and the last selected candidate in the UR category has obtained 101/200 marks whereas the Appellant secured 96/200 marks. Hence the case of Ms.Pavitra Sangwan could not be considered beyond the available notified vacancies.

Smt. Geeta Dalal, one of the selected candidates, has obtained 107/200 in Part-II (Main) Examination under post code 42/10 for the post of PGT (Geography). Moreover, Smt. Geeta Dalal, though being an OBC candidate, has secured more marks than that of the last selected candidate in the UR category; therefore, she was selected and placed under UR category as per rules. Further, Smt. Geeta Dalal was shortlisted under UR category only in the Part-I Examination for the said post code and she also did not take any benefit of OBC category.

In view of the above facts, the claim of Ms.Pavitra Sangwan is not tenable and is therefore rejected.

This issues with the approval of the competent authority, DSSSB.
