<u>ORDER</u>

Sub: Order/direction of the Hon'ble CAT passed in OA NO.2347/2011 titled as

Pinky Vs GNCTD and Ors. on 16-02-2012.

The Hon'ble CAT in OA No.2347/2011 titled as Pinky Vs. GNCTD and Ors.

has passed the order which is reproduced as under:

"15. In the above facts and circumstances of the case, we dispose of this OA

with the direction to the DSSSB to verify the genunity of the OBC certificate

submitted by the applicant on 15-01-2009 received by them vide their dispatch

no. 474 on 22-01-2009. If it is found genuine, it shall consider her inclusion in

the list of short listed candidates under the OBC category and nominate her

name to the user department within a period of one month from the date of

receipt of a copy of this order subject to the eligibility in all other aspects. On

receipt of such nomination from DSSSB, the user department shall consider

to appoint her as Teacher (Primary) within

a period of one month thereafter, it she is found otherwise eligible. On such

appointment, the applicant will be entitled for all consequential benefits

except backwages. However, if the user Department has got any doubt

regarding her creamy layer status, they may consider her case in accordance

with the instructions issued by the Government of India, DOP&T vide their

aforesaid order dated 25-7-2003 which has been extracted above. There shall

be no order as to costs."

In compliance of the above direction of the Hon'ble CAT, the case of Ms. Pinki has

been re-examined. In this regard it is to say that the result of the post code 016/08 was

declared by this Board on 06-10-2009; As per policy of this Board, the descriptive

answer sheet in respect of non-shortlisted candidates for post code 016/08 were

weeded out after the approval of Competent Authority, DSSSB on 12-05-10.

In view of the above, the result of Ms. Pinki cannot be processed in respect of Part-

Il of the said examination.

Therefore, it is regretted that the case of Ms. Pinki, Roll No. 01625817 cannot be

considered for the post of Teacher (Primary) under the post code 016/08.

This issues with the approval of the competent authority, DSSSB.
