1	112211500191	Two years Diploma in Computer Science or Degree in Computer Science is required as per RRs. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 to upload two years diploma in Computer Science or Degree in Computer Science but he failed to upload the same. Hence, rejected for not having requisite qualification as per RRs.

1	121111500003	PH certificate with 50% disability in spastic hemiparesis whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
2	121111500021	PH certificate with 40% locomotors disability whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
3	121111500030	PH certificate with 61% disability of all four limbs whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
4	121111500006	PH certificate with 81% locomotor disability whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.

5	112111500015	PH certificate with 70% disability of PPRP with homoplegis whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
6	112111500013	PH certificate with 100% hearing impairment whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
7	112111500017	PH certificate with 40% of both lower limbs whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
8	121111500025	PH certificate with PPRP with paralysis with 75% disability whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
9	112111500014	PH certificate with 54% disability of both lower limbs whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
10	112111500016	PH certificate with 75% disability with locomotion lower limbs whereas PH vacancy is notified for multiple disabilities category. Hence, rejected for not having PH certificate in multiple disabilities. He was given two opportunities w.e.f. 04.02.2022 to 13.02.2022 & 15.03.2022 to 19.03.2022 but he failed to upload the same.
