## JUNIOR STENOGRAPHER (ENGLISH) (POST CODE 94/20) IN DELHI TOURISM & TRANSPORTATION DEVELOPMENT CORPORATION Ltd.

- 1. The DSSSB vide its Advertisement No. 05/2020 with closing date 27/02/2020 had advertised 02 vacancies (UR-02) for the post of Junior Stenographer (English) in Delhi Tourism & Transportation Development Corporation Ltd (DTTDC) under Post Code 94/20. Board Conducted Tier-I written examination for recruitment in respect of this post on 19/04/2021.
- 2. The marks obtained by **1430** candidates who have duly appeared in written examination (online mode in single shift) held on **19/04/2021** have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module <a href="https://www.dsssbonline.nic.in">www.dsssbonline.nic.in</a>
- 3. Based on the performance in Tier-I written examination, 52 (Fifty Two) candidates as detailed below, have been provisionally shortlisted to appear in Skill Test/Typing Test and Short Hand Test, as per policy, subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Skill Test/Typing Test separately.

- 4. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Skill Test/Typing Test does not entitled them any right over the post.
- 5. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies.
- 6. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in one Tier written examinations for UR Category Candidate is 40%.

- 7. The qualified candidates for appearing in Skill Test/Typing Test have been called as per Board Policy, i.e. 50 (Fixed); however all the candidates who have score marks equal to the cut off marks in UR category have been shortlisted.
